1.1 Legal framework of the youth information service

The Czech Republic is obliged # as per Section 17 of the Convention of Rights of the Child, which is an integral part of the legal system of the Czech Republic # to ensure for children the access to information and materials from various sources and to support the media in propagating information that is socially and culturally useful. The Czech Republic adopted a Charter on Information for Youth. In addition to the above-stated, a public discussion on the White Book on Youth published by the European Commission was held; some items concerning information for youth are also included into the Conception of the State Policy with respect to the young generation in the Czech Republic adopted by the government in January 1999 and they are also included in the White Book of the Ministry of Education, Youth and Sports of the Czech Republic.
