

Yes, Slovenia has mobile info points, mainly in primary and secondary schools, at fairs and other exhibitions, and furthermore permanent stands in schools. Actually there are projects of constant mobile informative activity in 8 different communities: Maribor, Brezice, Koper, Ptuj, Krsko, Sezana, Ruse, Ljubljana.
