5 Legal basis/legislation for voluntary activities in general and for young people in particular

5.1 Legal status of volunteers

There is no particular legislation regarding volunteers. Neither are they assimilated to other categories.

5.2 Taxation/tax exemptions for volunteers and volunteer organisations

Taxation of volunteers is an area that is not specifically defined in Swedish fiscal legislation. The Swedish National Tax Board has however decided that benefits and pocket money received by volunteers participating in the European Voluntary Service should be exempted from tax. Swedish volunteer organisations would normally be covered by the tax laws establishing tax exemptions and other privileges for non-profit organisations. There are both exemptions of income, payroll and wealth taxes and also regarding inheritance and gift taxes.

5.3 Existence of social protection of volunteers

There is no specific protection by volunteers due to the lack of legislation regarding this group and the lack of assimilation to other categories with defined status in the social care, health care or pension system.

5.4 Legal situation of unemployed young people participating in voluntary activities

There is no specific legislation covering volunteers. Neither is this group assimilated to other categories with defined status in the unemployment insurance system.

6 Programmes

6.1 Programmes and plans on volunteering (national, regional, local)

Voluntary work has a long tradition in Sweden, especially within leisure and sports associations. Voluntary work in conventional public welfare services is much less common. The Swedish youth organisations offer the main opportunity for young people to take part in voluntary activities. In 2006 the youth NGOs received 24 000 000 EUR in direct support from the government. The number of young people participating in voluntary service programmes is rather small compared to the number involved in ordinary voluntary work in the youth organisations. Still there are around 25 different voluntary service programmes involving around 1 800 participants every year. Examples are the Swedish Church/Ecumenical Diaconal Year Network, The Swedish Centre for International Youth Exchange - CIU, IKU/ICYE and European Voluntary Service.

8 Development of voluntary activities, including standards/instruments aiming at securing and enhancing quality in voluntary activities

8.1 Recent (this year) developments in the area of voluntary activities

During 2006 the Committee of inquiry for issues related to non-governmental organisations launched a number of initiatives to highlight the situation of Swedish NGOs. A report will be issued during 2007. The Ministry of Education, Research and Culture received 2006 a report by the reaserch unit at Ersta Sköndal University College on the situation of voluntary service programmes in Sweden. The report presented a survey of Swedish organisations working with voluntary service programmes and listed a number of areas where further action might be needed. The situation regarding the formal status of full time volunteers in Sweden is to a large extent influenced by the fact that this is a rather new idea that up till now has involved only a small number of young people. The Government is now considering how to proceed with these matters.

8.2 What are the trends concerning the range of voluntary activities? *Increasing Decreasing* Stable

Explanation

Traditionally, voluntary work in Sweden has been carried out by members of an NGO and within the framework of the NGO. Most voluntary work has taken place within leisure and sports associations. Voluntary work in conventional public welfare services has been much less common. During recent years new forms of voluntary activities has developed. One of the most interesting examples is Volontärbyrån (the office for voluntary work) http://www.volontarbyran.org where potential volunteers can search for tasks (such as helping pupils with homework, visiting elderly people and assisting refugees) introduced by a large number of NGOs and other organisations. These tasks are often clearly defined and limited in time, and attract many persons wishing to contribute to society but not by committing themselves to a specific NGO.

8.3 Description of quality standards used in voluntary activities

The National Forum for Voluntary Social Work has developed a policy for voluntary social work. The policy is accompanied by educational material, reports, etc. that aims at establishing a common basis for governmental organisations, municipalities, NGOs and others involved in voluntary work in this field.

8.4 Description of measures to improve the quality of voluntary activities for young people

There is an ongoing process in the Swedish youth organisations focusing on the development of voluntary youth work, involving training, evaluation, funding, etc. This quality development process takes place within each organisation and is also a part of their joint work in LSU, the National

Council of Swedish Youth Organisations. During 2006 the youth organisations received 24 000 000 EUR in governmental support, allowing them to develop their activities according to their own priorities. Quality development is as well an important part of the organisations and programmes working with full time volunteers, such as European Voluntary Service and the Swedish Church.

9 Removing obstacles to young people#s voluntary engagement

9.1 The facilitation of young people#s voluntary engagement

The voluntary engagement of young people has until now mainly taken place within the framework of the youth organisations. The government#s main efforts to facilitate voluntary engagement has therefore focused on the situation of NGOs; providing generous financial support for their activities, establishing a fiscal framework taking account of the specific nature of NGOs, developing a policy for NGOs in a dialogue with the NGOs themselves, etc.

9.2 Recent (this year) measures to remove obstacles to young people#s volunteering

The Ministry of Education, Research and Culture received 2006 a report by the reaserch unit at Ersta Sköndal University College on the situation of voluntary service programmes in Sweden. The report presented a survey of Swedish organisations working with voluntary service programmes and listed a number of areas where further action might be needed to remove obstacles. The situation regarding the formal status of full time volunteers in Sweden is to a large extent influenced by the fact that this is a rather new idea that up till now has involved only a small number of young people. The Government is now considering how to proceed with these matters.

9.3 Existing obstacles

There are obstacles in fields such as legal situation, taxation, social protection, etc. The obstacles are to a large extent related to the fact that there is no specific legislation regarding this group, neither is it assimilated to other categories with defined status in the social care, health care or pension system or the unemployment insurance system.

10.2 Promotion activities for voluntary activities

The NGOs are themselves the main actors when it comes to promoting voluntary activities in Sweden. Being dependent on the contribution of thousands of volunteers they are constantly trying to reach new potential volunteers that would like to be involved in their work. The methods of promoting voluntary activities vary from organisation to organisation. A number of NGOs and municipalities organised activities during the UN International volunteer day 5 December, focusing on the positive contribution to society by volunteers in Sweden.

10.3 Initiatives to promote voluntary activities among young people from disadvantaged backgrounds

Swedish NGOs involve young people from disadvantaged backgrounds in a broad spectre of activities. The methods of these organisations vary, depending on their field of work and which group of disadvantaged young people they work with. Some of the organisations working with voluntary service programmes have developed strategies for reaching disadvantaged youth in particular. Examples are The Swedish Centre for International Youth Exchange # CIU (working with youth centres/dialogue with parents), Service Civil International Sweden # IAL (working towards employment offices) and the Swedish National Agency for European Voluntary Service (working with sending/hosting organisations with specific competencies in this field).

11 Recognition of voluntary activities of young people

11.1 Initiatives for recognition 'good practices'

The Government has appointed a national commission on validation in order to develop the

processes of quality and methods for validation. As a part of this work, the National Council of Swedish Youth Organisations # LSU was commissioned to develop models and methods for recognition of competences acquired by non-formal and informal learning. During 2006 the Swedish Centre for International Youth Exchange # CIU developed a method for the recognition of international competences; ELD (experience, learning, description). The organisation has now initiated a pilot project for testing the method.
