### 3 Finance

#### 3.1 Amount of finance that is annually available for Voluntary activities and allocation of this finance

It is not possible to specify the total amount of funds available for voluntary activities as their number and variety is very broad.

Through the Child and Youth Plan the Federation ensures the framework for an effective infrastructure of youth organisations, organisations in the field of child and youth services and welfare organisations on the federal level. This well-funded infrastructure mainly fosters voluntary activities of young people. Besides the Federation funds temporary model programmes and specific activities in the field of volunteering.

Moreover, specific voluntary activities of young people in the field of technical relief, environmental protection, agriculture, alimentation and consumer protection are funded by the Federal Ministries for Home Affairs, for Environment and for Agriculture.

On the regional level the federal states have similar child and youth plans to fund youth work. The most important public sources of funding lay here in the hands of the 680 local youth welfare offices.

The civic services Voluntary Social Year (FSJ) and Voluntary Ecological Year (FÖJ) are funded by the host organisations/association, the German federal states, third-parties and federal funds. In 2007 the budget for civic services was raised by one million euros. All in all, the federal government supported both services with about 19 225 000 Euro. Furthermore, the persons who carried out a civic instead of a civilian service were funded with about 20 million euros. The civilian service is based on a mixed financing with money coming from host organisations/association, social insurance carriers and the federal government.

Non-public voluntary services are funded by the volunteers and their parents themselves, private organisations/associations or third parties (i.e. churches, lottery income, private foundations).

In 2008 the new civic service “weltwärts” focussing on development countries will be implemented.

The Federal Ministry for Economic Development and Cooperation will fund this service with about 70 million euros (ca. 10 000 places) per year.

## 5 Legal basis/legislation for voluntary activities in general and for young people in particular

### 5.1 Specific legal status of volunteers

Voluntary activities & Voluntary Service

There is no specific legal status for volunteers in Germany. Volunteers have to act along the general legal conditions which partly regulate voluntary work in the aim to protect volunteers from specific risks, to compensate [financial] disadvantages resulting from volunteering, to promote volunteering through qualification or counselling, to create individual incentives for volunteers and to make volunteering possible.

Guidelines for the Development Volunteer Service

These laws/guidelines regulate the possibilities of deployment, pedagogical support and observation, include provisions on the host organisations working in the field, or on the authorisation of new ones, and regulate age-limits as well as the allowance for and social security of the volunteers.

According to sec 14 of the Law on the Civilian Service (Zivildienstgesetz) young men can carry out a civic service (Voluntary Social Year/Voluntary Ecological Year) instead of a civilian service.

## **5.2 Taxation of volunteers and volunteer organisations**

A new law from 2007 supports volunteering by tax reductions. Since 1st January 2007 persons who volunteer and who receive a small allowance for their commitment do not have to pay taxes up to an amount of 500 Euros per year. Furthermore, the tax-exempt amount for trainers was raised to 2100 Euros.

Tax exemptions for non-profit organisations do exist.

## **5.3 Existence of social protection of volunteers**

Voluntary Activities

Most of the people engaged in voluntary activities have an accident insurance and a casualty insurance which is paid by the organisation/association they are volunteering for. In cases in which such insurances do not exist the insurance coverage is covered by special insurances provided by the federal states.

Voluntary Service

Volunteers who carry out a voluntary service have to care about their insurances themselves. Often the organisations offering the places help to conclude the necessary insurances.

Voluntary Services abroad

For those people carrying out a voluntary service abroad additional insurances and measures for social security are necessary depending on the host country's conditions. Questions regarding this

### Civic Service

In particular with regard to social security, young people who sign up for a civic service are more or less on par with other young people who are doing vocational training. The host organisations provide pocket money, accommodation, meals, working clothes or can pay a lump sum to cover these expenses. Volunteers have complete social security coverage (statutory pension, accident, health care, long-term nursing care and unemployment insurance). Their parents receive family benefits and the volunteers are given travel cost reductions on the German Railways and on public transport. The Voluntary Social Year and the Voluntary Ecological Year are both recognised by the Central Office for the Allocation of Places in Higher Education as waiting time for such a place. For participants who carry out their service abroad the sending organisations are obliged to take care of the necessary social insurance.

## 5.4 Legal situation of unemployed Young people participating in Voluntary activities

According to sec 119 subsec 2 Social Code Volume II unemployed people can participate in voluntary activities up to 15 hours per week without having disadvantages in respect to their earnings-related benefits.

Development Voluntary Service (weltwärts): In 2008 the Federal Ministry for Economic Cooperation and Development together with its partners is going to start a new kind of voluntary service called "weltwärts" (toward the world). Young people between 18 and 28 are invited to work between 6 and 24 months as volunteers in projects in development countries. During this time they are financially supported (The Development Ministry will cover the costs of accommodation, travel, training and a small allowance). ## 7 Relationship between different services

### 7.1 Relationship between military service, civilian service, civic service and voluntary service in the country

Those young men who refuse to do military service for conscientious reasons have to do a civilian service. Like the military service the civilian service is regulated by the state and is considered as a service under public law with detailed legal regulations. While the military service encompasses nine months the civilian service lasts twelve months.

It is possible to do a civic service (Voluntary Social Year or Voluntary Ecological Year) instead of a civilian service. In 2006/2007 4600 young men used this opportunity.

Moreover there is the possibility to do the "Other Service abroad" (Der Andere Dienst im Ausland). In praxis this means that young people having carried out such a service are released from doing a civilian service – given that the service abroad lasted at least 14 months and that they did it for an organisation recognized by the Federal Ministry for Family Affairs, Senior Citizens, Women and Youth.

### 7.2 Plans to create voluntary civic service if not existing

There is a voluntary civic service in Germany.

## **8 Development of voluntary activities, including standards/instruments aiming at securing and enhancing quality in voluntary activities**

### **8.1 Recent (this year) developments in the area of Voluntary activities**

In September 2007 the Federal Ministry for Family Affairs, Senior Citizens, Women and Youth launched the programme "Civic services qualify" (Freiwilligendienste machen kompetent) which aims at facilitating the access to these services for disadvantaged young people, especially young people with a lower educational and/or a migration background. In the framework of this programme places of the Voluntary Social Year/Voluntary Ecological Year are specifically tailored to the abilities and needs of this target group.

Moreover the preparations for a new voluntary service in development countries ("weltwärts") were concluded in 2007. In 2008 the first young people will be able to carry out this service supported by the Federal Ministry for Economic Cooperation and Development. Quality standards are being developed for this voluntary service. More information: [www.weltwaerts.de](http://www.weltwaerts.de).

For 2008 the federal government plans to adopt a new law on civic services. This new law will improve the conditions for civic services by i.e. flexibilising their time structure and allowing volunteers to carry out a combined service in Germany and abroad.

### **8.2 Which other means, measures and instruments does your country apply in order to develop the voluntary activities of young people?**

The agency QUIFD (Quality in Voluntary Services), which issues organisations offering voluntary services and following certain quality standards with a certificate, extended its service in 2007. Now it is also able to certificate those organisations that function as responsible bodies (Trägerorganisationen) in the field of voluntary services. Before certificates were only issued to organisations sending or receiving volunteers. More information: [www.quifd.de](http://www.quifd.de).

In November 2007 the German Federal Youth Council launched a project on further developing the national youth leader card "Juleica" which certificates that its owners attended a special qualification training. Among other issues the project aims at developing nationwide minimum qualification standards for the "Juleica" training courses. More information: [www.dbjr.de](http://www.dbjr.de).

In the field of international youth work the "Nachweise International" (International Certificates) issued to young people who took part in an international youth activity could be further established. Launched in 2006 this system of certification offers the possibility to issue certificates on different levels (participation, engagement, competence). ## 9 Removing obstacles to young people's voluntary engagement

### 9.1 How is Young people's voluntary engagement facilitated?

Young people are encouraged to become a volunteer through various information channels as well as by projects or actions programmes. Furthermore, the recognition of voluntary activities plays an important role. In some federal states voluntary activities are included in the school curricula.

To inform young people about the numerous possibilities of volunteering the Federal Ministry for Family Affairs, Senior Citizens, Women and Youth, the bodies for statutory and voluntary youth services and youth welfare and the federal states developed a considerable information and advice network. Among other offers the Federal Ministry for Family Affairs, Senior Citizens, Women and Youth provides a brochure on voluntary services as an online and a print version (print run: 50 000 copies per year).

## 9.2 What recent (this year) measures have been taken to remove obstacles to Young people's volunteering? (legal, administrative measures, etc...)

The federal government prepared a new law on civic services which aims at improving the conditions for civic services by i.e. flexibilising their time structure and allowing volunteers to carry out a combined service in Germany and abroad.

## 9.3 What obstacles still exist?

Selection:

Although the budget for the civic services was raised there are still not enough places. Every year the number of applicants is much higher than the number of places. In average, there are about twice as much interested people as there are places in the programmes.

Young people who would like to carry out a voluntary service outside the civic service (no financial support) often cannot afford the costs.

Potential organisations/associations that would like to offer places for volunteers (civic service) cannot afford the monthly costs for the young persons.

Legal conditions have become more restrictive (reduction of the maximum duration for family benefits, introduction of tuition fees in some federal states) which has obstructive effects on the voluntary activities.

The status of young volunteers in the cross-generational voluntary services is not clear in regard to social security obligations.

Lack of financial resources for projects and initiatives (i.e. lack of basic funding).

Young people between the age of 14 and 18 with lower educational background have less opportunities in application processes.

Disadvantaged young people who would like to become active, cannot afford the cost for travelling and for participation or membership fees.

Long lead times: Young people cannot apply on short-notice for civic services or voluntary services abroad although it could be helpful in order to bridge waiting time (i.e. between graduation and vocational training or university).

The regulations for international voluntary services are seen as too tight and not practicable. More flexibility is needed.

The status of volunteers going abroad is often unclear. Sometimes they are seen as employees which causes a lot of problems.

Employers still see voluntary commitment as a disadvantage. They fear special leaves.

## 10.2 Promotion activities for Voluntary activities (events, support for promotion actions, contact persons)

Examples:

Social Day (Sozialer Tag) 2007: On 19th June 2007 200 000 pupils in Germany went to work for one day in an enterprise instead of going to school. Their wages were donated to education projects for children in Africa (2.1 million euros). The action day was supported by several minister presidents of the federal states and the Federal President Horst Köhler. The aim of the action was to encourage

Campaign "Role models educate" (Vorbilder bilden): In June 2007 the Bertelsmann Foundation launched the campaign to encourage young people to become active as volunteers and to become a role model for others. ### **10.3 Initiatives to promote Voluntary activities among Young people from disadvantaged backgrounds**

Examples:

Competition "Involvement and integration of migrants through civic engagement": The foundation "Citizens for citizens" (Bürger für Bürger) awards a prize for projects and ideas on jointly voluntary activities of Germans and migrants. The prize money amounts to 7000 Euros. The prizes are handed over during a high-visibility event in Berlin in the presence of the German official integration representative. Programme "Civic services qualify" (Freiwilligendienste machen kompetent): In September 2007 the Federal Ministry for Family Affairs, Senior Citizens, Women and Youth launched this programme focussing in particular on disadvantaged young people. The programme facilitates the access to voluntary engagement in the Voluntary Social Year and the Voluntary Ecological Year. The aim is to encourage disadvantaged young people to become active in society and to foster their training and job opportunities by doing such a service.

### **11.1 How (by which means) are voluntary activities of young people recognised?**

### **11.2 Do certificates on the voluntary activities of young people exist?**

Jugendleiter/in-Card (Juleica): The “Jugendleiter/in-Card (Juleica)” is a certificate for young volunteers who are active in an voluntary organisation. They attended a special qualification training and are at least 16 years old. The card documents the engagement and the qualification of the youth leaders and gives various reductions for community services, cultural offers etc. ([www.juleica.net](http://www.juleica.net)). The Juleica is the most common certificate for young volunteers in Germany. Ca. 3000 cards are issued each month.

Some federal states have an own form of certifying qualifications. In Baden-Württemberg the “Qualipass” documents practical experiences and competences of young people between the age of 12 and 25 acquired by voluntary commitment but also by traineeships, stays abroad etc. ([www.qualipass.info](http://www.qualipass.info)). Other federal states have similar forms of documenting voluntary commitment of young people (i.e. Hamburger Nachweis, Berliner FreiwilligenPass, EhrenamtsCard in Hessen).

Young people who carried out a Voluntary Social Year or a Voluntary Ecological Year have a right to receive a certificate informing about the form and the duration of their voluntary service. The certificate can also include a performance rating and the vocational qualifications the young people acquired during their service.

Since 2006 voluntary activities of young people in international contextes are recognised by “International Certificates” (Nachweise International). These certificates document the participation, the commitment and the shown competences of young people who took part in international activities (also those realised in Germany). ### **11.3 By whom are the voluntary activities of young people recognised**

In most cases the documents certifying voluntary activities of young people are issued by youth organisations or organisations/associations offering places for voluntary services which are officially recognised as voluntary or statutory bodies in the youth sector.

In regard to the International Certificates the Participation and the Commitment Certificate can be issued by all bodies (mainly voluntary organisations) active in non-formal international youth work. But the authorisation to issue the International Competency Certificate is given only to specialists and

experienced team leaders who are already qualified and have a special training. More information:

#### **11.4 Does society as such recognise voluntary activities of young people? If so how (by which means)?**

Competitions and awards are high-visibility means to recognise and honour volunteers.

Examples:

Citizens Award “für mich, für uns, für alle” (for me, for us, for all) honours citizens who showed an extraordinary commitment in the field of voluntary work. The category “JUNIOR” awards young people until the age of 21, [www.buerger-engagement.de/1\\_initiative/index.php](http://www.buerger-engagement.de/1_initiative/index.php).

Every two years the Federal Ministry for Family Affairs, Senior Citizens, Women and Youth and the German Federal Youth Council award the Heinz-Westphal-Preis to young people doing extraordinary voluntary work. The prize money amounts to 15 000 euros, <http://heinz-westphal-preis.de>.

Groups, associations and single persons who are voluntarily active in Baden-Württemberg can participate in the competition “Echt gut!” (Really Good) – Voluntary Engagement in Baden-Württemberg”. The competition is divided in seven categories. A jury makes a preselection and all inhabitants of Baden-Württemberg can vote for their favourites. Since four years the Federal Working Committee of Volunteers’ Agencies (Bundesarbeitsgemeinschaft der Freiwilligenagenturen) awards an innovation prize to innovative project ideas of volunteers’ agencies aiming at solving social problems by voluntary commitment. In general events and meetings (i.e. general assemblies) on national level offer a lot of face-to-face opportunities for young volunteers to exchange experiences. Apart from this online services like platforms or contact fairs support the exchange among volunteers on the local and regional level.

In regard to voluntary/civic services:

For volunteers carrying out a Voluntary Social Year/Voluntary Ecological Year accompanying regular seminars are integral part of the programme. These seminars provide a space where the young volunteers meet to share and to reflect their experiences as well as to broaden their knowledge on issues related to their service.

#### **12.4.3 Please describe in how far the government/state administration is involved in organising, supporting and implementing international solidarity service in non-EU countries**

The government strongly supports international solidarity services in non-EU countries. The Federal Law on the Promotion of the Voluntary Social Year (Gesetz zur Förderung eines Freiwilligen Sozialen Jahres) and the Federal Law on the Promotion of the Voluntary Ecological Year (Gesetz zur Förderung eines Freiwilligen Ökologischen Jahres) as well as the Law on Civilian Service foresee the possibility to carry out the service as an international solidarity service in non-EU countries (under certain conditions).

Furthermore, the Federal Ministry for Economic Development and Cooperation together with the organisations/associations active in the field of international solidarity is going to launch “weltwärts”, the new civic service in development countries, [www.weltwaerts.de](http://www.weltwaerts.de).
