1 Structures and actors that play a role in gaining a greater understanding and knowledge of young people

In 2005, the Ministry for Children and Family Affairs has formed the Council of Youth Policy Coordination, (www.jaunatneslietas.lv) where National Youth Council of Latvia and Latvian Student Association are actively involved. It is the first consulting and coordinating institution on state level, and it has the aim to promote the development and implementation of youth policy in the country and the involvement of youth in the process of decision making. It is an open council, and its main function is to ensure coherent implementation of youth policy in the country, as youth policy is carried out by different organisations. The Youth Policy Coordination Council is chaired by the Minister of Children and Family Affairs.

1.1 Specific youth departments in universities dealing with youth issues

No departments dealing with youth issues. Institute of Philosophy and Sociology, University of Latvia, regularly initiates youth research.

1.2 Statistic offices that collect statistics on youth

Central Statistical Bureau (www.csb.gov.lv) collects official statistics.

1.3 Major public and semi-public bodies dealing with youth issues

Institute of Philosophy and Sociology, University of Latvia, regularly initiate youth research: Youth Participation (2005), Youth in the Labour Market (2007), EKAD study (field work in Riga City in 2006, published in 2007).

1.4 NGOs dealing with youth issues

Latvian Youth council (LJP), Latvian Student association (LSA), Youth council of the Latvian Free Trade Union Association (LBAS) might have practical knowledge on needs and expectations of young people. However, NGOs do not undertake research on young people.

1.5 Youth researchers or experts

There is a group of youth researchers (Trapenciere, Koroleva, Rungule, Snikere, Trapencieris) at the Institute of Philosophy and Sociology, University of Latvia (Director M.Kūle) that performs regular youth research on national level. The main areas of research: youth participation, youth in the labour market, leisure time and deviant behaviour, quality of youth life. The group of researchers organises regular seminars and conferences on youth research.

Baltic Institute of Social Sciences has performed some research on risk of social exclusion of youth risk groups (2006-2007). Laboratory of analytical and strategic studies has performed a research on Youth social and political activities (2007).

1.6 Private companies dealing with youth issues

Baltic Institute of Social Sciences has undertaken a few applied studies on integration of young people with low educational level.

No specific quality assurance strategies in youth research. The quality assurance strategy in youth research is based on Code of Ethics in Sociological research (Sociological Association of Latvia). However, there are cases, when according to the Law on Purchase the applicant of the lowest price is chosen, and the quality is lower.

9 Promotion of youth researchers and their generational renewal and their actors who work towards a better knowledge of youth

9.1 Facilitating the exchange of experience and practice

No formal national networks on youth research established. In collaboration with the Nordic Youth research association, young Latvian Youth researchers have participated in the NYRIS seminars for the doctoral students. Conferences on youth research are organised by the researchers from the Institute of Philosophy and Sociology about every third to fourth year (previous conference was in 2005, next takes place in 2008).

9.2 Supporting their mobility

During the NYRIS programme for doctoral students in Youth research, Latvian participants received funding for the mobility from the NYRIS programme.

9.3 Improving their skills (language, cultural ...)

Participants of the NYRIS programme for doctoral students in Youth research improved language, cultural knowledge and skills, improved theoretical and methodological knowledge on youth research, participated in practical workshops.

There is a communication between representatives from various ministries on the issues related with youth health, education, employment etc. There are regular working group meetings on concrete issues related to youth. However, researchers are not invited to participate in such meetings.
