## 1. Volunteering of young people in Romania

General recommendations on volunteering: Voluntary Law from 2001<sup>1</sup>

There are recommendations only at national level

Voluntary work is not paid

There is no National Voluntary Service in Romania

#### Volunteer's legal status

Romanian and foreign citizens are considered volunteers if they carry on their own activities organized by public legal entities and private legal entities, not for profit, in the spirit of civic solidarity.

#### Voluntary agreement

Voluntary activity must be conducted under a written contract between the volunteer and the beneficiary of volunteering within which there must be specified both obligations and rights. The contract states that the volunteer will actively participate in the proper development of the programs he is involved in. The tasks assigned to the volunteer must be consistent with his abilities, professional knowledge and physical skills, so that his physical and mental health is not affected. The volunteer is responsible for any moral damages and material damages caused to the host-organization by his own fault.

The volunteer must fulfill the duties imposed by the beneficiary, maintain the confidentiality of information he has access to. He is obliged to attend the training sessions organized by the beneficiary for a better process of acquiring knowledge in the specific field.

The Voluntary agreement cannot be signed in order to avoid signing an individual employment contract or a civil services contract. Otherwise, the contracts are void.

The voluntary agreement has also to include at least the following rights of the volunteer:

- Providing the beneficiary, as provided by the law, insurance against risks of accident and disease arising from the nature of the activity; in case of no medical insurance costs are covered entirely by the beneficiary;
- Issuing, by the beneficiary, of a nominal certificate to certify the quality of volunteers;
- Repayment by the beneficiary, under conditions agreed in the contract, according to the law, of the expenses made in carrying out the activity;
- Working-time duration, established under the provisions of the law, not to affect the volunteer's health and psycho-physical well-being;
- Possibility to receive honorary degrees, medals, awards, according to the law.

#### Professional benefits for volunteers:

At competitions for filling of the posts, if two or more candidates obtain equal scores, the authorities and public institutions as well as private individuals may give additional points to those candidates that have one or more nominal voluntary certificates which recognize the volunteer's work and experience acquired, provided that these are within the selection criteria.

Obstacles to young people's engagement in volunteering

There is still a negative perception about volunteering, especially amongst older generations- due to the Communism period. Therefore, somewhat discouraged youngsters have to engage in unpaid activities.
