

1. Volunteering of young people in Slovenia

The status of volunteers is regulated by recently adopted law on volunteers. There is no tax exemption for volunteers. Performance of voluntary activities or voluntary service does not give volunteers the rights arising from pension and disability insurance (as is the case of the employed), unemployment insurance, parent care insurance, work accident insurance and professional disease insurance.
