## Youth policy symposium with EECA countries

### Concept Paper

**Dates:** 13-14 November 2013

**Venue:** Armenia

**Partners:** Ministry of Youth of Armenia, SALTO Resource Centre for Eastern Europe and Caucasus, European Youth Forum

**Main theme:** Role of youth work in education for democratic citizenship and participation.

#### **Outline:**

Education for democratic citizenship and youth participation are challenging topics throughout Europe and represent a common focus of both the EU and the Council of Europe youth policy. The goal of this event will be to examine the situation more closely in the context of Eastern Europe and South Caucasus. What is the situation of education for democratic citizenship and youth participation in the region? How can the education for democratic citizenship and participation be further developed and made accessible to all young people through education (formal and non-formal)? How can the national and local authorities, but also the society at large become more receptive for youth participation and self-expression? Equally, in a region that still has its share of conflict, how can we foster transnational and cross-cultural interaction of young people and through education for democratic citizenship and human rights education support young people in overcoming the spirals of hatred and conflict? These will be some of the questions that the event will strive to address. The structure of the event will allow for discussion from a regional perspective, as well as for a more targeted view of the specific needs and situations per country.

The event would follow the workshops on youth policy development in Eastern Europe and the Caucasus (Budapest, Hungary 2008; Konstancin-Jeziorna, Poland 2009), the symposium on Youth Policy Cooperation in the EECA region in Odessa, Ukraine in July 2011 and the symposium on youth policy and health and well-being of young people in the EECA region in Tbilisi, Georgia in June 2012. It would again serve as a platform for exchange and furthering discussions on youth participation and evidence based youth policies in the region, in line with the conclusions of the previous events. Links with the EU's Eastern Partnership Youth Window of the Youth in Action Programme and the Council of Europe's Human Rights Education Youth Programme will be established.

## **Participants:**

The symposium will bring together approximately 50-60 key stakeholders of the youth field from different countries of the region (and some experts from other parts of Europe), including in particular national governmental authorities in charge of youth and education, youth workers and youth leaders with interest and experience in the topic, but also representatives of municipalities/districts (depending on structures existing in countries), researchers and other relevant stakeholders, e.g. from formal education and employment sectors, as well as National Agencies and SALTO Resource Centres of the Youth in Action Programme.

## **Policy Context:**

Both the CoE and the EU continue to place great importance on cooperation in the youth field with EECA countries. In the 2012-2013 period, the European Commission allocated 31.5 million euros for cooperation within Youth in Action Programme with the Eastern Partnership countries through the "Eastern Partnership Youth Window". The European Commission supported the establishment of Eastern Partnership Youth Regional Unit whose purpose is to, inter alia, support capacity development of government and civil society actors in the youth sector in Eastern Partnership countries and encourage the involvement of a broad range of stakeholders.

The Council of Europe's Charter on Education for Democratic Citizenship and Human Rights Education (2010) calls on member states to adopt "the aim of providing every person within their territory with the opportunity of education for democratic citizenship and human rights education". The Charter builds on the experiences of the Human Rights Education Youth Programme, which the youth sector initiated in 2002, centred on manuals Compass and Compasito. The Council of Europe Action Plans with individual countries, include also capacity-building for youth organisations and youth workers in mainstreaming human rights education and EDC in youth work. The framework cooperation agreements of the Council of Europe with the Russian Federation and with Ukraine are also largely based on youth participation and human rights education. These are also underlying the No Hate Speech Movement campaign, which all countries in the region have joined.

National youth policy reviews and a summary report for the region were produced by the EU-CoE youth partnership in 2011 and discussed at the Odessa Symposium. They shed the necessary light on the situation in the youth field in the region and served as a first step for discussing further development. With the 2012 symposium that took place in Tbilisi, the regional cooperation moved from a general discussion on youth policy development to discussing a particular theme of well-being and health of young people in the region. This year's event will continue in the same line by focusing its discussions on the role of youth work in education for democratic citizenship and participation.

## **Themes**

### Overall theme

- Role of youth work in education for democratic citizenship and participation- a knowledge based approach to youth policy-making and to practice development in the region.

### **Aim:**

To better understand, demonstrate/exemplify and promote the role of youth work in education for democratic citizenship and participation.

### **Objectives:**

- Initiating dialogues, discussions, debates, exchanges and possible co-operations among all stakeholders;
- Creating opportunities for peer-learning
- Presenting good practices
- Learning from research based evidence and improving policy and practice
- Come up with conclusions and ideas on how to enhance policy-making and practice in this field

### **Main themes**

- Creating and fostering links between youth policy and youth work in the field of education for democratic citizenship, human rights education and participation: policy, research and practice perspective
- Role of youth work in supporting cross-cultural interaction of young people
- Role of new technologies in fostering education for democratic citizenship and participation
