### SustainMobility conference, 26 February-1 March, Schloss Hohenkammer, Germany

<u>SUSTAIN-MOBILITY</u> was the fourth conference of the European Platform on Learning Mobility (EPLM) in the youth field. It was hosted by JUGEND für Europa, National Agency for the EU programmes Erasmus+ Youth and European Solidarity Corps in Germany, in co-operation with the EU-Council of Europe Youth Partnership and other EPLM members. The conference brought together over 120 practitioners, researchers, policymakers from local, regional and national levels and young people to discuss this important topic.

- established a common understanding of sustainability in the area of youth learning mobility, with a holistic focus on the economic, socio-cultural and environmental dimensions of sustainability;
- mapped the main actors and practices and gave visibility to their work;
- explored main dilemmas related to sustainability in the context of learning mobility;
- raised political awareness of sustainability in nonformal education settings and the youth policy area and connected stakeholders and initiatives.

Participants had an opportunity to hear the perspectives of representatives from the four angles of practice, research, policy and young people.

The event was received quite positively and proved that the topic requires further discussions and research. EPLM UPDATES

The EPLM is also preapring two papers related to quality and learning mobility:



### Q!App survey

<u>Q!App</u> is a quality tool to support organisations preparing learning mobility projects. It was launched in 2019 and so far has been used in more than 15 countries with over 1500 active users. It is based on the <u>EPLM quality principles</u> and indicators and enables collaboration online with project partners.

Currently, JINT is evaluating the usage of the Q!App. A <u>survey</u> has been launched to check how the Q!App is perceived and promoted within the European Youth field, identify needs, gaps and add new resources. ### Supporting learning mobility: progress, obstacles and a way forward

European Commission is in the process of proposing a Council Recommendation on a new framework for learning mobility, in order to establish learning mobility as a standard all individuals practice for involved in education, training, youth, and sport, rather than an exceptional occurrence. To contribute to the evidence base and identify both incentives and obstacles to learning mobility, the study was launched mapping and analysing existing evidence and studies on cross-border learning mobility across formal, non-formal, and informal settings in the European Union and beyond.

Additionally, the study evaluated the current practices of data collection and monitoring, and proposed strategies to enhance the existing learning mobility data monitoring system. The findings and policy recommendations from this study will serve as valuable inputs for the Commission's preparation of the proposal for the new Recommendation, scheduled for the third quarter of 2023.

### **Eurodesk Annual Overview 2022**



### Social Media Guidebook 2023

The *guide* published by Eurodesk provides information about the basics of digital branding, different social media channels essentials, and how to improve online presence and services. It helps select the best tools and approaches and supports the development of social media communication strategies in youth information services.







### The European Youth Event (EYE), 9-10 June, Strasbourg, France

The *European Youth Event*, organised by the European Parliament, serves as a platform that unites thousands of young individuals from across the European Union and beyond, both in person at the European Parliament in Strasbourg and through online participation. EYE 2023 provided a space for 8500 young people, aged 16 to 30, to come together, share their perspectives, and develop a variety of skills.

By interacting with experts, activists, influencers, and decision-makers, the participants had a unique opportunity to engage, inspire, and learn from one another. This year, two special tracks were highlighted in the programme: Green Track and Election Track, placing a focus on the sustainability dimension and the upcoming European elections in 2024.

### The Inclusion & Diversity Forum, 25-28 April, Bucharest, Romania

During this international conference, participants were given the opportunity to be involved in thoughtful reflection, exchange best practices, share tools and resources, and engage in discussions on strategies to promote greater inclusion and diversity within the EU Youth Programmes. The event served as a platform for celebrating stories, inspiring one another, and fostering a sense of togetherness.



The Forum was organised by SALTO Inclusion & Diversity and prioritised a broad understanding of inclusion and diversity, following the definition that encompasses young people facing fewer opportunities.







#### Strengthening capacities for European Youth Card governmental youth agendas: European Youth Card as a tool to bring youth in governance, 3-6 April, Evora and Lisbon, Portugal

The Partial Agreement on Youth Mobility make use of the European Solidarity Corps through the Youth Card organised a study visit in Programme as a tool for social cohesion capacity Portugal to strengthen the governmental youth agendas.

The event was held in collaboration with EYCA. and a Portuguese partner, Movijovem. The study visit created a platform for knowledge exchange and inspiration by bringing together government representatives from the Partial Agreement member states to explore strategies and best practices in youth policy development and program implementation, following the Council of Europe standards.

### Activating citizens – municipalities/local authorities making use of the European Solidarity Corps, 13-20 June, online

The main aim of the seminar was to motivate and support municipalities to of and solidarity.

Participants explored how to bring sustainable added value to the local community by supporting the active engagement of young people in voluntary activities or solidarity projects to achieve social cohesion in local communities.


The seminar was hosted by the European Solidarity Corps Cyprus, the SALTO Solidarity Corps Resource European Centre and the *Europe Goes Local* network.

### 5th European Event of Europe Goes Local (EGL), 23-25 May, Stockholm, Sweden

The event gathered 170 representatives of national working groups and European, national and local stakeholders to discuss crucial issues in local youth work. The emphasis was on strengthening national cooperation, highlighting the role of national and local stakeholders in developing local youth work, using European tools, policies and frameworks.

### **Inclusive and Participatory Digital Transformation**

The Digital Transformers long-term training course, spanning from October 2022 to April 2023, organised by the SALTO PI, was an all-encompassing endeavour designed to boost the capabilities of youth workers in the realm of digital youth work. This comprehensive programme employed an array of innovative learning methods, comprising four online training courses, a residential training session held in Lithuania, and an invigorating study visit to Armenia. Throughout these training modules, participants delved into pivotal themes such as digital well-being, ethics and digital rights, and digital sustainability, with an unwavering commitment to fostering active participation and inclusive practices.



The training course was thoughtfully structured around a hybrid model, encompassing twelve events, including six panels and six training sessions. Residential events provided valuable networking opportunities and hands-on learning experiences, allowing participants to apply their knowledge in practical settings. Panels, on the other hand, served as informative platforms, offering valuable insights and expertise. The online training courses facilitated an in-depth analysis of the information received during the panels and served as spaces for participants to refine their ideas and further develop their skills.

This project was co-funded by the Erasmus+ Programme of the European Union by National Agencies Belgium-FL, Austria, Finland, Estonia, Iceland, Italy, Lithuania, Portugal and SALTO Resource Centres: Inclusion & Diversity, Participation & Information and Eastern Europe & Caucasus.

### Media and Information Literacy Project LAB, 23-25 May, Tallinn, Estonia

Media and Information Literacy Project Lab brought together 35 participants passionate about addressing crucial issues such as fake news, cyber-bullying, sextortion, digital security, and other topics related to Media and Information Literacy. The event provided them with an opportunity with media and to engage information disorder experts, deepen their understanding of Media and Information Literacy, exchange ideas and experiences and collaborate with fellow participants on development of tangible project ideas that can make a meaningful difference.



### Capacity-building for strengthening youth policy, 29-30 March, Chisinau, Moldova

Youth Partnership's Shaping youth policy in practice capacitybuilding project brought together delegations from Armenia, Bosnia and Herzegovina, Hungary, Portugal, Ukraine and Moldova. The aim of the seminar was to improve the professionalisation of youth work, development of youth law, and strengthen international mobility and inclusion of Roma young people.



During the seminar, participants learned about the many standards and youth policy support measures from the European Commission, Council of Europe, SALTO Eastern Europe and Caucasus and the Youth Partnership. The delegations will develop their policy implementation plans during the year with guidance from experts and resources. ### Growing youth work in Europe, 31 May - 1 June, Budapest, Hungary

The <u>Youth Partnership</u> organised the symposium <u>Visible Value: Growing youth work in Europe</u> in the European Youth Centre Budapest, at the mid-point between two European Youth Work Conventions. This event took stock of the future steps in youth work development and the implementation of the European Youth Work Agenda (EYWA), and streamlined and promoted a continuous constructive dialogue with the community of practice. Over 100 participants from the European youth work community had a space for networking, sharing tools for practical support, and discussing the latest research findings on youth work development. The symposium also offered room for an active dialogue about what action and support is needed to step up the pace towards a strengthened, structured, and recognised youth work throughout Europe, and for reflecting on emerging trends and issues.

### Review Seminar on Recommendation CM/Rec(2017)4 on Youth Work, 3-4 April, Strasbourg, France



The Council of Europe's <u>Recommendation</u> <u>CM/Rec(2017)4</u> is the first internationally agreed policy document that explicitly focuses on youth work. This year it is time to have a look at its impact! A <u>review seminar</u> on the recommendation brought together 20 participants at European Youth Centre in Strasbourg. Representatives of ministries as well as civil society discussed the implementation in member states, shared

### Youth Research Methodology Seminar, 22-24 May, Hamburg, Germany

The seminar hosted approximately 40 participants from the EU and neighbouring partner countries. This diverse group consisted of youth researchers, researchers from related fields, practitioners and stakeholders with a keen interest in youth research methodologies within international and intercultural contexts. The seminar was co-hosted by the National Agencies of the European Youth Programmes from Finland and Germany. The activity was organised within the framework of the RAY Network by the RAY Network Coordination and the RAY Transnational Research Team.

SALTO Participation & Information gathers exemplary projects for the Participation Resource Pool, demonstrating effective participatory practices within the Erasmus+ and European Solidarity Corps Programmes. The goal is to highlight high-quality examples from all Key Actions. There are currently six projects showcased within the youth and youth workers' mobilities under Key Action 1 of the Erasmus+ Youth programme, and the number of projects included increases every year.

The projects are sourced from various channels, including the SALTO Awards, recommendations from National Agencies, and thorough research conducted on the Erasmus+ Projects Platform. Interviews are conducted with project coordinators and, whenever possible, participants gain insights into the key characteristics and step-by-step approach of each project. The ultimate aim is to provide a comprehensive understanding of these projects, enabling others to replicate their approach.

### **Europe Talks Solidarity**

<u>Europe Talks Solidarity</u> is a series of events, podcasts and publications by SALTO European Solidarity Corps to enhance and explore the concept of solidarity in local, international and global contexts. Recently, the second series of <u>podcasts</u> was launched. So far, eight new episodes cover a wide range of topics connected to solidarity. They touch upon the characteristics of a solidary city, the relationship between solidarity and basic needs, the role of money in solidarity, the comparative

solidarity of different generations, promoting humanitarian solidarity responsibly, the impact of solidarity on societal health, the potential for Europride to foster solidarity within the European LGBT+ community and what can sustain solidarity in the face of violent conflicts.

The <u>podcast Talking Youth Work</u> started its third season. The podcast formula is based on interviews with practitioners who introduce innovation to youth work.


### Young women's political participation


### Gems of Youth Work

The *publication* on Mentoring and Coaching within the European Solidarity Corps provides a closer look at the current mentoring and coaching practices within the European Solidarity Corps programme. Based on data collected through desk research, surveys, focus groups and interviews, the research concludes with 14 insights and recommendations for National Agencies and communities of practice.

The research is part of the strategic initiative <u>Mentoring Under Construction</u>, commenced by the <u>SALTO European Solidarity Corps</u> together with the Romanian National Agency for Erasmus+ and European Solidarity Corps in 2020.

Based on the research recommendations, the Mentoring Under Construction community initiated building a mentoring competence framework which would clarify the role and responsibilities of a mentor, the competencies that are needed to fulfil this role and ethical standards for mentoring within the ESC programme.





### Navigating Transitions - Adapting Policy to young people's changing realities

A <u>report</u> from the EU-Council of Europe Youth Partnership flagship event in the framework of the <u>#EYY2022</u> was released. The symposium Navigating Transitions - Adapting Policy to young people's

changing realities

took place in Tirana. Albania. the European Youth Capital 2022 on 21-23 June and brought together 105 participants from 35 countries to reflect on what paradigm shift is needed in youth research, youth policy and youth work to support people's young aspirations.



### **European Academy on Youth Work**

The <u>report</u> from the 2nd European Academy on Youth Work gathers comprehensive insights from the event and explores innovation in youth work.

In June 2022, the second EAYW event was successfully held in Slovenia, bringing together more than 160 participants from the European youth work community of practice. The event provided a platform for participants to delve into over 30 innovative practices and engage in discussions about the essential elements required to initiate, support and sustain innovation in youth work. ### **Creating Community Impact through Solidarity**

It examines the diverse ways in which projects and organisations generate meaningful outcomes within communities, by analysing a collection of 15 practical examples. These actions encompass a range of initiatives, including solidarity projects, team volunteering projects and individual volunteering projects.



# **PUBLICATIONS**

#### **Green Inclusion Seminar**

An external report of the Green Inclusion Seminar, gathering inputs. recommendations and resources, was published. Additionally, an internal report gives details of the programme and how the outputs were created. The seminar took place in Amersfoort, Netherlands, on 15-18 November 2022 and gathered together 36 practitioners from 12 countries to start discussions on the nexus of green inclusion and its meaning in the youth sector. The seminar looked at connections between the two horizontal priorities of the European Educational Programmes: diversity and GREEN inclusion; and the environment and the fight against climate change.

### YOCOMO Competence Model



The revised edition of the <u>YOCOMO- A Competence Model for Youth</u> Workers to Work Internationally has been released. The model covers nine competencies through four learning dimensions (Attitudes, Knowledge, Skills and Behaviour). One notable addition to the competence set for youth workers is the emphasis on "Being Civically Engaged." This particular competency centres around enabling youth workers to be conscious of and adopt principled positions on political and societal matters that impact young individuals.

It entails actively challenging power dynamics, facilitating value-based processes, engaging in collaborative endeavours with young people, and fostering their critical civic participation in communities, both within Europe and beyond.

YOCOMO Training of Trainers 2023-2024 is now accepting applications. The course will prepare trainers to implement training activities for youth workers with competence-based holistic and systemic approaches, in their context.

### **ID** Talks Magazine

SALTO Inclusion & Diversity Resources Centre published the ID Talks Magazine. # WHAT'S ON THE HORIZON

### SALTO Awards - October 2023

The call for nominations for <u>SALTO Awards</u> was published. This year, the winners will get 700€ prize money and their project will feature alongside the promotion of SALTO Awards winners on SALTO communication channels.

The contest is open to projects from the Erasmus+ and European Solidarity Corps Programme and partner countries (Regions 1-3). SALTO will consider nominations submitted by 16 August.

Prizes will be given at the Youth Participation in Democratic Life event in October 2023 in Lublin, Poland, the European Youth Capital. In the meantime, watch the videos about the <u>2022 winning</u> <u>projects</u> and get inspired!





SALTO Awards aim to honour and acknowledge the outstanding achievements that have resulted from learning mobilities. The Awards serve as a platform to showcase innovative practices, effective methodologies, and inspiring success stories that have emerged from learning mobilities. Priority is given to projects that have demonstrated a high level of quality in terms of planning, implementation and outcomes. The jury is seeking to highlight projects and initiatives that have made a tangible difference in the lives of young people and the communities they belong to.

### Walk the talk, 5-7 July, Luxembourg

The Partial Agreement on Youth Mobility through the Youth Card, in co-operation with EYCA will organise an interactive seminar, *Walk the Talk* in Luxembourg on 5-7 July 2023.

The seminar will promote the European Youth Card as a tool for policy development and implementation, at local, national and European levels, especially to Government representatives, and share good practices on how EYCA members develop the European Youth Card.



### European Rural Youth Summit, 5-9 September, Aroneanu, Romania

The European Rural Youth Summit will gather 150 young people, youth workers, youth activities organisers and decision-makers to enhance the rural youth ecosystem in Europe. The event will create a space for dialogue between rural youth and decision-makers on the challenges and opportunities facing rural areas in Europe and provide a learning and participatory context for rural youth to engage with experts and peers on rural development issues.

The event is organised by the European Youth Village Programme's Governance (Active Development Association ADA and Go Free Association) and the Romanian National Agency of Erasmus+ and European Solidarity Corps programmes together with the young people and the mayor's office from Aroneanu.

The European meeting for organisations in the European Solidarity Corps -SoliDARE, 18-22 September, Prague, Czech Republic

The second edition of the SoliDARE event will gather representatives from organisations and informal groups active in European Solidarity Corps. The event aims to continue building up the community of organisations in the programme. It will include inputs from experts, an open space for participants and space to exchange solutions to the challenges that the organisations are facing in implementing projects supported by the European Solidarity Corps programme.



### Youth on the Move – InfoMobility eLearning course, 2 October - 10 November, online

ERYICA is organising an open training course, <u>Youth on the</u> <u>Move- InfoMobility</u> (YoMIM), which will be run under the



Council of Europe-ERYICA partnership agreement. Registration will be open in August. YoMIM refers to the provision of information, guidance, and counselling to young individuals during their stay in a foreign country. Specifically, the YoMIM serves as a valuable addition to existing youth information services, with a particular focus on young people participating in cross-border European mobility programmes and offering guidance and essential information to help young individuals make the most of their time abroad and access valuable resources.

The manual for the course will be available in English, Spanish and French.

### SNAC Volunteering Conference 2023 -Shaping Volunteering in Europe and Beyond, 4-6 October, Podgorica, Montenegro

As part of its initiatives, the Strategic National Agencies Cooperation (SNAC) on Volunteering is organising an international event called the "Volunteering Conference". The primary objective of SNAC is to enhance the European Solidarity Corps Programme and promote solidarity within EuSC-volunteering.

SNAC commissioned several pieces of research and analysis on volunteering and its position within the EU programmes and National schemes. The conference will be the space to introduce the results of the research and collect responses and feedback from important stakeholders in the programme



### TEC Forum 2023, 27-31 August, near Warsaw, Poland

The TEC (Training and Evaluation Cycle in European Solidarity Corps) Forum is a seminar designed for trainers active in the European Solidarity Corps and National Agencies officers who implement the TEC learning cycle. This year it will focus on structures, strategies and tools supporting the well-being of volunteers, trainers, and NA staff in TEC.

### Youth Knowledge Book: Youth and Democracy in the climate crisis: Call for Papers

<u>EU-Council of Europe Youth Partnership</u> launched a <u>call for</u> <u>abstracts</u> for a new Youth Knowledge Book. The publication will cover young people's experiences with the climate and biodiversity crisis, youth engagement with the climate justice and sustainability movements and the responses of the youth sector and youth policy across Europe to young people's environmental activism. Send your abstract proposals by 15 July!



### **RAY (Research-based analysis of European Youth Programmes)**

RAY Monitoring on the European Youth Programmes <u>survey</u> has been launched. For the first time after the pandemic, participants and project team members of the Erasmus+ Youth and the European Solidarity Corps programmes are invited to reflect on the effects of the projects and activities, as well as on their own learning pathways and competence development. The research aims to analyse the impact of the European Youth Programmes at individual, organisational, community and European levels. Respondents will be invited to the questionnaire via a link sent by email.

In the meantime, RAY Network invites participants involved in the Erasmus+ Youth Programme to contribute to an anonymous survey on learning outcomes, strengths and areas for improvements in the programme. This research will involve representatives of 34 countries and will attempt to discover the effects of the European youth programmes.
