TENDER FILE / TERMS OF REFERENCE(Competitive bidding procedure / One-off contract)

Purchase of facilitation services for the Visible Value Regional Seminar



The Council of Europe is currently organising, in the framework of its partnership in the field of youth with the European Commission, a regional seminar: *Visible Value – Strengthening the Implementation of the European Youth Work Agenda in Eastern and Southeast Europe* to take place in November 2022 in Sarajevo, Bosnia and Herzegovina. The exact dates of the seminar (15-17 or 22-24 November) are to be confirmed. The seminar will bring together 70-80 participants to reflect on the way the youth work sector and community of practice have fared since the 3rd European Youth Work Convention and what structures and mechanisms have been put in place to deliver on the commitments made during the Convention and in the European Youth Work Agenda framework document. The Youth Partnership is looking for two facilitators for planning and organising the event. The preparatory meeting of the seminar is foreseen to take place in person on 4-5 October in Sarajevo.

A. TENDER RULES

This tender procedure is a competitive bidding procedure. In accordance with Rule 1395 of the Secretary General of the Council of Europe on the procurement procedures of the Council of Europe¹, the Organisation shall invite to tender at least three potential providers for any purchase between €2,000 (or €5,000 for intellectual services) and €55,000 tax exclusive.

This specific tender procedure aims at concluding a **one-off contract** for the provision of deliverables described in the Act of Engagement (See attached). A tender is considered valid for 120 calendar days as from the closing date for submission. The selection of tenderers will be made in the light of the criteria indicated below. All tenderers will be informed in writing of the outcome of the procedure.

The tenderer must be either a natural or a legal person.

Tenders shall be submitted by email only (with attachments) to the email address indicated in the table below, with the following reference in subject: Tender-facilitation services for the Visible Value Regional Seminar.

Tenders addressed to another email address will be rejected.

B. EXPECTED DELIVERABLES

The expected deliverables are described in **Section A of the Act of Engagement** (See attached).

C FFFS

All tenderers are invited to fill in the **table of fees** as reproduced in **Section A of the Act of Engagement**.

Tenderers **subject to VAT** shall also send **a quote (Pro Forma invoice)** on their letterhead including:

- the Service Provider's name and address;
- its VAT number;
- the full list of services;
- the fee per type of deliverables (in the currency indicated on the Act of Engagement, tax exclusive);
- the total amount per type of deliverables (in the currency indicated on the Act of Engagement, tax exclusive);
- the total amount (in the currency indicated on the Act of Engagement), tax exclusive, the applicable VAT rate, the amount of VAT and the amount VAT inclusive.

D. ASSESSMENT

Exclusion criteria and absence of conflict of interests

(by signing the Act of Engagement, you declare on your honour not being in any of the below situations²) Tenderers shall be excluded from participating in the tender procedure if they:

- have been sentenced by final judgment on one or more of the following charges: participation in a criminal organisation, corruption, fraud, money laundering, terrorist financing, terrorist offences or offences linked to terrorist activities, child labour or trafficking in human beings;
- are in a situation of bankruptcy, liquidation, termination of activity, insolvency or arrangement with creditors or any like situation arising from a procedure of the same kind, or are subject to a procedure of the same kind;
- have received a judgment with res judicata force, finding an offence that affects their professional integrity or serious professional misconduct;
- do not comply with their obligations as regards payment of social security contributions, taxes and dues, according to the statutory provisions of their country of incorporation, establishment or residence;
- are an entity created to circumvent tax, social or other legal obligations (empty shell company), have ever created or are in the process of creation of such an entity;
- have been involved in mismanagement of the Council of Europe funds or public funds;
- are or appear to be in a situation of conflict of interest;
- are retired Council of Europe staff members or are staff members having benefitted from an early departure scheme;
- have not fulfilled, in the previous three years, their contractual obligations in the performance of a contract concluded with the Council of Europe leading to a total or partial refusal of payment and/or termination of the contract by the Council of Europe;
- are or if their owner(s) or executive officer(s), in the case of legal persons, are included in the lists of persons or entities subject to restrictive measures applied by the European Union (available at www.sanctionsmap.eu).

Eligibility criteria

- At least five years of experience in the youth sector as a trainer in non-formal education, understanding of relevant youth policy frameworks and how they apply to youth work (demonstrated in the CV);
- Concrete demonstrated experience in facilitating larger scale (more than 50 participants) international/European level event(s), such as seminars, conferences or symposia (demonstrated in the CV).

Award criteria

- Quality of the offer (90%), including:
 - Experience in training, education and in specific facilitating seminars, conferences, plenary sessions and symposia based on non-formal education methodology; (50%)

⁻ An extract from the record of convictions or failing that an equivalent document issued by the competent judicial or administrative authority of the country of incorporation, indicating that the first three and sixth above listed exclusion criteria are met;

⁻ A certificate issued by the competent authority of the country of incorporation indicating that the fourth criterion is met;

⁻ For legal persons, an extract from the companies register or other official document proving ownership and control of the Tenderer;

⁻ For natural persons (including owners and executive officers of legal persons), a scanned copy of a valid photographic proof of identity (e.g. passport).

- Knowledge of youth work policy and practice of Eastern and Southeast Europe and being familiar with the current developments in the European youth work field and with realities of the community of practice. (40%)
- Financial offer (10%).

The Council reserves the right to hold interviews with tenderers.

Multiple tendering is not authorised.

E. NEGOTIATIONS

The Council reserves the right to hold negotiations with the bidders in accordance with Article 20 of Rule 1395.

F. DOCUMENTS TO BE PROVIDED

Tenderers are invited to submit:

- A completed and signed copy of the Act of Engagement³ (See attached)
- For tenderers subject to VAT <u>only</u>: **a quote, describing their financial offer**, in line with the requirements of section C of the Tender File (see above);
- A list of all owners and executive officers, for legal persons only;
- A curriculum vitae.
- A motivation letter (maximum 1 page) highlighting the relevant expertise and experience of the
 applicant, including a list of examples of similar deliverables (e.g. seminars, conferences or other
 events) with links and clearly stating availability for the preparatory meeting on 4-5 October 2022
 and for the seminar on 15-17 or 22-24 November 2022 to participate in person in Sarajevo, Bosnia
 and Herzegovina.

All documents shall be submitted in English, failure to do so will result in the exclusion of the tender.

If any of the documents listed above are missing, the Council of Europe reserves the right to reject the tender.

The Council reserves the right to reject a tender if the scanned documents <u>are of such a quality that the documents cannot be read once printed.</u>
