We launched "The Social Incubator" Association in April 2014 and we knew, since then, that it would be an important milestone for each of us.

At the very first beginning, we set out to contribute of increasing the chances of social and professional integration of vulnerable young people in our country.

Also, since the first year of activity, we have created the main program of the organization - **Tineri de Viitor/Life Project**

Supporting youth people who have left or are forced to leave the foster care system (16-26 years) has become the main focus for the association.

Anton

He is 20 years old and entered the foster care system when he was only 1 year old, being the only one of the 3 children in the family to be abandoned. Until the age of 14, he lived with two foster carers, and later ended up in social apartments until the age of 18. He entered the association's programs happy that he would have a chance to achieve his goals.



Judit

She is 19 years old and entered the system at the age of 5. Her mother and her partner had drinking problems and physically abused her. At 15, he met his 4 younger sisters, but was unable to form a relationship with them. However, Judit is determined to overcome her condition and help young people who are in similar situations.



Aurel

He entered the system at birth when he was abandoned at the maternity ward. He lived in the foster care center until he was 5 years old, and then in the foster family. For the past two years, he lived with other young people in a social apartment. He always maintained his optimism that one day he would be able to have some stability.

SOCIAL ENTREPRENEURSHIP





RetuŞArt is a social entrepreneurship project established by The Social Incubator Association. Conceived as a social enterprise, the workshop offers tailoring and touch-up services for the general public or directly at the company's' premises (being extremely convenient for busy people).

HOW YOU CAN HELP

REDIRECT FOR FREE 20% FROM THE PROFIT TAX

Give them a chance for a better future by directing the tax you pay anyway to the state!

- It is a FREE service. The Sponsorship Law (32/1994) and the Fiscal Code (227/2015), allow companies to give to an NGO 20% from the profit tax that has to be paid to the state (the state receives the rest of 80%)
- If you didn't provide sponsorship support from the amount of 20% of the tax in 2022, you now have the possibility to retroactively redirect the remaining amounts by completing form 177

INVOLVING THE EMPLOYEES
