A CONTINUUM OF CHALLENGES

COMPETING 'PERSPECTIVES'

• WIDER (YOUTH) POLICY BEYOND THE YOUTH SECTOR

CONCEPTUAL EVOLUTION

- Youth Rights
- Social Justice
- Generational fairness
- Polycrisis affecting youth in Europe? Inequalities and precarity
- Wraparound initiatives 'input from' and 'impact on'
- Strengthening 'perspective'; embedding 'mainstreaming'
- Education, empowerment and capacity building

PARTICIPATION-PERSPECTIVE(S)-MAINSTREAMING

- Strengthening participation meaningful?
- Integration of youth perspectives across the policy field?
- Is participation a principle and prerequisite for youth mainstreaming?
 Or is it a necessary but not sufficient precondition?
- Enabling and Ensuring youth consultation and engagement
- Enabling voice
- Ensuring attention to impact (perhaps unforeseen consequences)

BUT.....?

- Different methodologies produce different perspectives how are these to be reconciled?
- Where are the distinctions with 'participation plus'?
- What about other approaches?
 - Youth checks and tests explore, assess, mitigate, amend
 - Young professionals in their professional worlds (categorical representation)
 - Youth research
 - Litigation (cf climate activism / and not just youth!)

BEYOND THE YOUTH SECTOR?

- The push of youth participation / perspective. Yes
- The pull of youth perspective / mainstreaming. Maybe not

 Can the youth sector be enlisted for the advocacy and organisation of youth mainstreaming? Will anybody listen?

- Recurrent structural challenges threaten sustainable anchoring
 - Political volatility
 - Institutional anchoring

CONCLUSIONS

- We should pay close attention to the lessons from gender mainstreaming at a European level (cf. a tribute to Teresa Rees)
- We must avoid getting tangled up in rhetorical pleasantries and weasel words - we currently remain very tied to youth participation (plus)
- We must remain alert to intersectional questions youth intersects with other critical dimensions of risk, exclusion, disadvantage, discrimination and more
- This is all work in progress and we should move forward cautiously
- There is a spectrum of issues, arguments, rabbit holes and possibilities
