

1 Information services

1.1 Legal framework of the youth information service

The Czech Republic is obliged – as per Section 17 of the Convention on the Rights of the Child, which is an integral part of the legal system of the Czech Republic – to ensure for children the access to information and materials from various sources and to support the media in propagating information that is socially and culturally useful.

The Czech Republic adopted the Charter on Information for Youth.

Besides, a public discussion on the White Book on Youth published by the European Commission was held; some items concerning information for youth are also included in the "Conception of the State Policy with Respect to the Young Generation in the Czech Republic" adopted by the Czech government in January 1999 and they are also included in the White Book of the Ministry of Education, Youth and Sports of the Czech Republic.

On 1st January 2008, the National Information Centre for Youth (=Informační centrum pro mládež, ICM) operated by Národní institut dětí a mládeže (National Institute of Children and Youth) based on the ratified Conception of the Development of National Information Centres for Youth in the Czech Republic. 2 Access for young people

2.1 Number of young people using the information services

Based on the analysis made by the Information Centres for Youth in the Czech Republic, in the year 2006 there were about 230 thousand contacts. (It can also be even several times more, no official statistics are recorded.)

2.2 Number of young people visiting the national and regional youth portals

Based on the analysis made by the Information Centres for Youth in the Czech Republic, in the year 2006 there were about 470 thousand visits of national and regional youth portals, but not all the Information Centres for Youth have quantified this, so it seems that the real numbers are higher than that.

2.3 Is there any mobile information service?

We are preparing an "infobus" (specially modified bus – a mobile Information Centre for Youth).
