1.1 Youth parliaments

1.1.1 Local youth parliaments

In Austria many local youth parliaments exists. A list is available at www.jugendbeteiligung.cc, the homepage of ARGE Partizipation, a network consisting of representatives of the federal and national youth departments in Austria. examples: Jugendgemeinderat Kufstein (Tyrol): Alex Molitor; the young people aged 14 to 20 in this parliament work for the the needs and wishes of the youth in Kufstein (Tyrol), the Juendgemeinderat Kufstein has an own budget which is administrated by the memebers. Jugendgemeinderat Weiz (Styria): Waltraud Graf; 25 bi-annualy elected young people aged 13 - 17 (7 apprentices, 9*2 pupils of different schools), 4 meetings the year with the mayor of Weiz. Jugendbezirksvertretung 15 (Vienna): Lisa Stanek, in moderated workshops pupils of the 7th grade in the Viennese 15th district develop their petitions and projects which are presented to the politicians

5.3 The right to vote

The National Council is elected in accordance with the principles of equal, direct, secret and personal right to vote. All Austrian citizens who have turned 18 on the election day are entitled to vote. There is no postal vote, but Austrians living abroad and Austrians not at their permanent residence at the time of elections can submit their votes by polling card. Voting is not compulsory. Citizens lose their right to vote and passive right to vote only if they have been convicted of criminal offences.

All citizens who have turned 19 on the election day have a passive right to vote, i.e. the right to be elected.

9 Learning to participate

9.1 Existing actions within the systems of formal education aiming at developing and deepening learning to participate

In Austrian schools exists due to the decree GZ 33.464/6-19a/78 the educational principal "political education". Curricula on this topic exist for every kind of Austrian school with the aim to enable young people to understand and perceive the different forms of democratic participation in Austria. According the "European Year of Citizenship through Education" national action days for models of good practice were established.

9.1.1 Mechanisms of participation at school

In schools representatives of the classes are elected, who elect the representatives of the schools, who elect on a national level their representatives. Pupils are also involved in the decision finding prozess in their school through the SGA. This body consits of three representatives of the teachers, the parents and the pupils each.

9.1.2 Learning of citizenship

The educational principal "political education" in Austrian Schools aim for the learning of citizenship in Austria. The implentation of "The European Year of Citizenship through Education" forsees the establishment of action days for political education.
