1 Structures of participation at the local, regional or national level

1.1 Youth parliaments

1.1.1 Local youth parliaments

In several municipalities are youth parliaments, they could be named as councils or parliaments. There is no clear model for parliament, so called parliaments are in different cities: Tallinn, Paide, Narva, Kuressaare, Pärnu, Valga, Jõhvi, Viljandi. The NGO called "Tegusad Eesti noored" (Estonian Active Youth; www.tn.ee) has been devoted to launch the youth parliament idea.

1.1.2 Regional youth parliaments

1.1.3 National youth parliament

Estonian Youth Policy Council works as national youth parliament. There are representatives from:
- 6 representatives of Estonian National Youth Counsil; - 1 representative of Estonian Youth Work Centre; - 2 representatives of the Estonian Youth Councellors Assosiation; - 1 representative of the Estionian National Agency for Youth programme; - 1 representative of the Ministry of Education and Research. 1.2 Youth councils

1.2.1 Local youth councils

There is no existing overwiev of local youth councils because there is no obligation for creating them and they have no clearly defined purpose. Therefore if local youth council is created it passes soon. Today there are actively operating following local youth councils: Youth Council in Jõgeva Municipality; Mr Karmo Kurvits (leader); Youth Council in Kuressaare; Mrs Tiina Luks (counsellor).

1.2.2 Regional youth councils

There are no youth councils in regional level.

1.2.3 National youth councils

5.3 The right to vote

The right to vote shall belong to every Estonian citizen who has attained the age of eighteen. An Estonian citizen who has been declared mentally incompetent by a court of law shall not have the right to vote. In the election of the local government council, all persons who have reached the age of eighteen years and who reside permanently on the territory of that local government unit shall have the right to vote, in accordance with conditions determined by law. So he or she has to be

resident in the territory of local government and has not been divested of his or her legal capacity by a court.
