The Youth Parliament: The Youth Parliament is an educational programme initiated by the Greek Parliament and organized on an annual basis with the cooperation of the Ministries of Education of Greece and Cyprus. Pupils from Greece from all levels and types of Lyceum # upper level of secondary education # (public, private, day time schools, evening schools, ecclesiastical, etc), from the Technical Schools of the country and from Greek schools abroad are able to participate in this programme following an intra-school selection procedure. The programme is also open to pupils from Cyprus, and in particular, to pupils from the A and B grade of the Lyceums and Technical schools of Cyprus. The Youth Parliament consists of 362 members (312 from Greece, 25 from Cyprus and 25 from Greek schools abroad). The main aim of the programme is to cultivate a positive attitude towards civic participation and democratic structures. 1.2 Youth councils

1.2.1 Local youth councils

Municipal Youth Councils: The Municipal Youth Councils are constituted within Municipalities and promote youth participation at the local level. They are composed of committees of representatives from secondary schools, local volunteer organizations, athletic and cultural organizations, operating within the boundaries of the Municipality. They record and attend to the needs of youth in the local society, make assessments and introduce proposals and petitions to the Municipal Council. They develop and put forward their own proposals regarding issues such as culture, work, drug-addiction, sports, education, voluntary work, racism and xenophobia, vocational orientation, ecology, peace, equality and access to information.

Prefectural Youth Councils: The Prefectural Youth Councils are constituted within Prefectures and promote youth participation at the regional level. Their role is consultative regarding youth issues.

1.2.3 National youth councils

The National Youth Council, ESYN, was established in July 1998 as a #platform# of NGYOs and is an independent, non-governmental, non-profit federation of Greek youth organizations. Today, 42 NGYOs constitute the National Youth Council (4 political party NGYOs, and a large number of non political ones), representing the vast majority of #organized# young people. The National Youth Council is the official representative of Greek youth abroad and the main interlocutor of the Hellenic Government on youth issues at the national level. It participates in the Inter-Ministerial Committee for Youth, in the Organizational Committee for the Youth Parliament, while it is a member of the European Youth Forum, the Mediterranean Youth Forum, the UNESCO Youth Council, the relevant U.N. For the further development of the institution of Municipal and Prefectural Youth Councils, the General Secretariat for Youth is promoting their institutionalization and their legal recognition according to the principles of the European Charter for youth participation in local life.

-One of the main political goals of the General Secretariat for Youth is to support the various structures for youth political and NGO participation. More specifically, with an open invitation to the public, interested organizations and groups are regularly invited to submit their proposals for any kind of youth activities. After an evaluation of these proposals, a great number of plans proposed by and addressed to young people are being financed throughout Greece. -Similar procedures of financing organisations and youth initiatives are in place in other Ministries and governmental agencies.

5.3 The right to vote

All Greek citizens are entitled to vote provided: -They are aged over 18. -They are registered in an electoral roll of some municipality or community in Greece. -They have not been deprived of their voting rights. The following persons are not entitled to vote: -Persons who pursuant to the provisions of the Hellenic Civil Code have been fully deprived of their right to exercise their civil rights on their own. -All those persons so deprived by virtue of an irrevocable criminal sentence for one of the crimes cited in the Penal and Military Penal Code for such time as that deprivation persists. In particular, according to the Greek Constitution, Article 51, #the law cannot abridge the right to vote except in cases where a minimum age has not been attained or in cases of legal incapacity or as a result of irrevocable criminal conviction for certain felonies#.

5.5 Eligibility to be a candidate

According to Article 55 of the Greek Constitution, #to be elected as a Member of Parliament, one must be a Greek citizen, have the legal capacity to vote and have attained the age of twenty-five years on the day of the election#.

9 Learning to participate

9.1 Existing actions within the systems of formal education aiming at developing and deepening learning to participate

Civic education modules are linked with cross-curricular activities and subject-specific themes at primary and upper secondary educational levels, with emphasis on democratic citizenship, introduction to law and political institutions, ancient Greek literature, history of the social sciences, European civilisation and its roots, and sociology.

9.1.1 Mechanisms of participation at school

The main mechanism of participation at school is the institution of Student Councils.

9.1.2 Learning of citizenship

Citizenship education in elementary and secondary schools as part of national curriculum. To give some examples, the module #European Civilisation and its Roots#, taught at the first grade of secondary education (upper level), examines the history and evolution of Europe and its distinct social and political formations. Moreover, at the second grade of secondary education (upper level), there exists a module under the title #Introduction to Law and Political Institutions#, which brings together the disciplines of law and political science, focusing on the nature of politics and the role of political science, the theory and practice of active citizenship, elements of democratic government, the legal and political system of the European Union, the Greek political and judicial system, etc. In addition, at the third grade of lower level secondary education, students engage themselves in the study of forms of citizenship, the democratic process and the Constitution, etc.

9.1.3 Other actions within the systems of formal education aiming at developing and deepening learning to participate

A series of events, organised by the Ministry of National Education and Religious Affairs, have taken place or are about to take place in order to foster and support the active and continuous participation of schools and other educational institutions in initiatives linked with the development of democratic citizenship. The forthcoming events include: #Strengthening Democratic Citizenship#, 4th Technical and Vocational Education School in the city of Kavala and #Assessing Students-Responses on Democracy and Human Rights#, in the 7th Lyceum of Larissa, both in October 2005.

Governmental authorities are developing an integrated package of initiatives and measures for the reinforcement of the political and social participation of young people. More specifically, the following measures are being undertaken and developed: -The General Secretariat for Youth is launching an information campaign to promote active citizenship in young people through the Network of Youth Information Centres and using newspapers, radio and television messages, as well as brochures and posters. In the same context, the General Secretariat for Youth is organising a series of events and happenings within the framework of the European Youth Week entitled #Youth Takes the Floor# between 5-11 December 2005. -Within the framework of the policy to reinforce youth participation, financially supporting organisations and collective initiatives of young people is vital. In this respect, the General Secretariat for Youth is implementing a special programme financially supporting relevant youth initiatives. -Special educational programmes on citizenship broadcasted by ET3, the third public television channel.
