In cooperation with the Slovenian Office of European parliament it hosted 3 employees of EP administration, who attended 5 round tables all over Slovenia - to discuss EU matters with young people. Different postcards were published encouraging the participation in the elections and distributed to youth organizations in Slovenia. At the same time a special web site that promoted the complete campaign was established. In September 2004 the campaign promoting participation at the National Parliament Elections started. A video clip was launched under the name Let it be your way!. It was frequently played on the national and some local televisions and in movie theaters.
