

### 1 Please explain the context of youth participation in your country

Youth are quite active and participative in various structures in our country. The National Youth Policy Document (2004) article 12 highlights participation of youths in all spheres of society. In the field of participation, the State follows a policy that:

- affirms the importance of an easily-accessible, adequate and relevant information programme as a fundamental requirement for the eventual effective participation of young people in community life.
- recognises that young people's competent influence should be assessed and achieved through dialogue and equitable representation.
- acknowledges that schools, youth organisations, the National Youth Council, local councils and other non-associated groups are the domains that should provide an ideal opportunity for nurturing participation skills and their implementation;
- involves young people in regular meetings and initiatives both at the local, regional and international level.

#### 2.1.3 Local youth councils

- Local Youth Councils This is project which is being implemented for the third year and encourages young people from the local community to form a youth council to make proposals and suggestions to the Government local council to improve its service to young people.
- Student Councils do exist in schools and Colleges
- Additionally, there are youth committees in various localities including youth who involve themselves in local youth organisations and band clubs.

#### 2.2 Youth parliaments on national, regional and local level (if applicable)

The National Youth Parliament (official name)

The National Youth Council organises the National Youth Parliament, and this year has been the fourth annual event. Youth between the ages of 13-17 and from 19-35 apply to take part. They choose the theme for discussion themselves according to national priorities, issue policy papers and discuss them at the house of representatives. There is no limited number of how many people can apply for this experience. Every young person who applies will be given the opportunity to participate. Participation of youth usually comes from secondary schools and youth organisations. The event usually takes place in September and youth are prepared for the event by participating in a weekend seminar, preparation meetings, day seminars and visits to the House of Representatives. On the day youth, vote on resolutions and propose amendments.

Citizens have the opportunity to vote during General Elections to elect government representatives, Local Council elections to elect Local Councillors and during MEP (European Parliament elections).We also have the opportunity to vote during referendums when the need arises.

#### 5.2 Age of the right to vote

The voting age in Malta is at eighteen years of age in all elections mentioned in 5.1

### 5.3 Please describe, who is entitled to vote in national, regional and local

#### elections.

General Elections:-

- Male and Female aged 18 and upwards
- Maltese Citizens
- Resident in Malta and has during the eighteen months preceding his registration been a resident for a continuous period of 6 months or for periods amounting in the aggregate to six months

Local Councils:-

- Every citizen of Malta whose name appears in the last published Electoral Register and who has not been convicted of any offence connected with the election of members of Local Councils.
- Every person who is a national of a Member State of the EU whose name appears in the last published EU Electoral Register and who has not been convicted of any offence connected with the election of members of Local Councils.

MEP elections:

- Every person whose name appears in the Electoral Register last published before the date fixed for the election
- every person whose name appears in the EU Electoral Register

From eighteen years of age upwards.
