European Commission

Until now there is no comprehensive legal framework for volunteerism in Greece; hence, volunteers in Greece do not have a specific legal status but they are assimilated to other categories of people depending on the case (eg: students, workers, etc). However, there are some national laws which refer to particular types of volunteerism. More specifically: -Law 2646/20.10.1998 regarding the Institution of the National Social Care System and, in particular, article 12, refers to the development of volunteerism and anticipates the establishment of an independent Department for the Development of Volunteerism within the Ministry of Health and Social Solidarity. -Law 2731/5.7.1999 regulates issues related to development aid which are financed and monitored by the Ministry of Foreign Affairs. -Law 3013/1.5.2002 regarding the Upgrading of Civil Protection regulates issues related to the development of voluntary civic service. -Law 1951/1991 establishes the institution of the volunteer fireman.

5.2 Taxation/tax exemptions for volunteers and volunteer organisations

None at present. However, donations to public benefit organizations are tax-exempt up to a certain level.

5.3 Existence of social protection of volunteers

There are no national standards or arrangements. Individual programmes and projects have their own arrangements regarding expenses, insurance, living allowances, etc. However, as far as European Voluntary Service (EVS) is concerned, participant volunteers in the programme are subject to the EU provisions.

7 Relationship between different types of voluntary services

7.1 Relationship between military service, civilian service, civic service and voluntary service

In Greece, military service is obligatory for all male citizens over 18 years old. However, the state gives the possibility of an alternative service to those people who do not wish to join the army for ideological or religious reasons. Alternative service can be either #unarmed# military service or civic (social) service.

7.2 Perspectives for the creation of a voluntary civic service in countries where it does not exist

As mentioned above, voluntary civic service does exist in Greece.

8 Development of voluntary activities, including standards/instruments aiming at securing and enhancing quality in voluntary activities

8.1 Recent (this year) developments in the area of voluntary activities

-The General Secretariat for Youth is planning the foundation of a National Organization on Volunteerism under the name #The House of Volunteerism#. This organization will constitute an #umbrella# that will function as a #bank# of volunteers, will connect various other organizations and informal groups of volunteers, will promote the idea of volunteerism and develop the necessary supporting structures. -The Ministry of Culture has announced the foundation of a new organisation, the so-called #Citizens# Work#, which will be responsible for the development of volunteerism in Greece. This organisation will occupy 31 persons and its annual budget will be 900000 Euros.

According to recent surveys and articles on volunteerism in Greece, the volume and the range of voluntary activities is increasing.

8.3 Description of quality standards used in voluntary activities

Basic quality standards: -The voluntary activities should provide knowledge, non formal learning and training opportunities, place for initiative and should encourage the sharing of experiences with other young people, as well as a better understanding of cultures, personal development and the acquisition of communications skills, etc. -The volunteer has to be respected as a human and a citizen in light of her/his fundamental rights. -The volunteer has to be covered by insurance during the voluntary service. -The volunteer has to receive adequate support and guidance to enable him /her to carry out his/her service, as well as working conditions that respect his/her personal health, safety and dignity. -The volunteer must not carry out particular professional tasks which would replace paid employees, or tasks that require professional responsibility. -The volunteer has to contribute her/his own ideas, creativity and experiences.

8.4 Description of measures to improve the quality of voluntary activities for young people

-Training seminars and Educational Programmes, at national and European level, for young volunteers, coordinators/mentors, youth workers, social workers and youth advisors in close cooperation between National Authorities, NGOs, Local Authorities, Voluntary Civic Services Organizations, etc. -Creation of databases for voluntary organizations (e.g. social, environmental organisations, etc.). -Information meetings at national level focusing on volunteering opportunities and on funding sources. -Creation of communication channels at national and European level through the recording of voluntary organisations, their approach and their networking. -Transfer of knowledge and good practice through the mobility of experts at national and European level (exchange of youth workers, representatives of social partners, network project coordinators etc.).

9 Removing obstacles to young people#s voluntary engagement

9.1 The facilitation of young people#s voluntary engagement

Young people#s voluntary engagement is facilitated through a better dissemination of the relevant information. In particular, this constitutes one of the main aims of the Youth Information Centres. In addition, the General Secretariat for Youth portal includes a #Time Bank# which helps young people allocate efficiently any spare time they want to devote to voluntary engagements.
