1. Types of voluntary activities existing in the country for young people,

There is a long and strong tradition of voluntary commitment of young people in Germany. Volunteering of young people can be found in many areas:

- Community activity
- Participation/self-governance
- Emergency response
- Community peacekeeping
- Social assistance
- Personal assistance
- Children and youth
- Environment
- Human rights, advocacy and politics
- Economic justice
- Development aid
- Humanitarian aid
- Religious volunteering
- Education
- Arts/culture
- Sports
- Recreation
- Consumer protection
- Preservation of historic monuments.

This is matched by an equally long tradition in sponsoring this kind of commitment by the German government, in particular by the Federal Ministry for Family Affairs, Senior Citizens, Women and Youth. Co-operation with the relevant support organisations has been and still is characterised by the subsidiarity principle on the basis of partnership.

According to the 15th Shell youth study carried out in 2006 36% of the young people in Germany between the age of 12 and 25 engage regularly in voluntary activities (ca. 4 million persons) and 42% from time to time (ca. 5 million persons).

2. Which kind of voluntary service exist in your country and how many young people engage in them per year, in totals and by gender.

Statutory Voluntary Services

1a. Voluntary Social Service Year (*Freiwilliges Soziales Jahr, FSJ*)

The Voluntary Social Service Year is a fulltime practical community work in non-profit organisations. It can be performed in

- social facilities (i.e. hospitals, homes for the elderly, kindergartens, welfare centres),
- youth works areas (i.e. youth centres, youth clubs, youth organisations),
- the field of culture (i.e. art and music schools, theatres, museums, libraries),
- the field of sports (i.e. in facilities offering sport activities for children and young people),
- the field of preservation of historic monuments.

1b. Voluntary Ecological Service Year (Freiwilliges Ökologisches Jahr, FÖJ)

The Voluntary Ecological Service Year is a fulltime practical community work in the field of nature conservation, environmental protection and education on sustainability. It can be performed i.e. in nature conservation projects, ecology groups, youth organisations focussing on ecological projects or educational establishments.

Participation criteria

Every young person who is under 27 years old and has completed his/her formal education can enrol in a civic service. A minimum age is no longer required. Depending on the federal state the young person lives in minimum school education ends at the age of 15 or 16. Recognised conscientious objectors may also perform a 12-month statutory voluntary service instead of an alternative civilian service. There are no prescriptions regarding the volunteer's nationality.

Duration

Normally the volunteers carry out the service for 12 months. The service time can be reduced to at least 6 months or be extended to maximal 18 months. Under certain conditions an extension to 24 months is possible.

Going Abroad

It is possible to enrol in one of these civic services abroad or to combine an assignment in Germany and in another country.

Statistics

Each year about 24,300 young people enrol in a FSJ/FÖJ. In 2006 among them about 1600 volunteers carried out their FSJ/FÖJ abroad (including 1075 young men performing their alternative civilian service as a civic service abroad). Since the start of the programmes in 1964 400,000 young people took part in one of the two programmes.

2. "weltwärts" - the Development Volunteers' Service

The development volunteers' service "weltwärts" (world bound) started in January 2008. It aims at promoting young people's engagement in development cooperation and is an educational programme promoting intercultural learning in development countries.

Possible sectors for assignments are the priority areas and sectors of German development policy (e.g. poverty reduction, education, health, food security/agriculture, environmental and resource protection, water, human rights, promoting democracy, youth employment and sport).

Participation criteria

The volunteers have to be between 18 and 28 years old and must be German citizens or non-German citizens who are permanent residents and have the right of residence in Germany. They must either have completed a vocational training course after graduating from school at 15 or 16; or have graduated from secondary school at 18 or 19; or have a university degree; or they must offer other proof of their suitability for volunteer service, e.g. by experience from doing alternative service. They must have a good basic knowledge of a language spoken in the host country.

Duration

The volunteers perform their service for at least 6 months and at maximum 24 months in the host country. In order to ensure the necessary integration of the volunteers into the structures of the partner organisation, the usual period is 12 to 18 months.

Statistics

Since the start of "weltwärts" in January 2008 the recognised sending agencies received more than 10,000 applications from young people, 60% of them sent by young women. About two-thirds of the applicants have graduated from secondary school, 10% have passed lower school-leaving examinations or a vocational training.

Until the end of September 2008 1530 volunteers started their service in 57 host countries. By the end of 2008 about 2000 volunteers had left Germany. The "weltwärts" programme aims at sending out about 10,000 volunteers per year.

Voluntary Services

Beside the three statutory voluntary services other voluntary services exist offered by German NGOs and associations, churches and other institutions. They are not co-funded by the federation. In 2006 about 12,300 young people carried out such a voluntary service funded by the volunteers and their parents themselves, private organisations, associations or third parties (i.e. churches, lottery income, private foundations).

Furthermore the federal government realised a model programme on **intergenerational voluntary services** (*generationsübergreifende Freiwilligendienste*) between 2005 and 2008 encouraging people of all age groups to become volunteers. The aim is to strengthen the cooperation between the generations and to support a new culture of voluntariness. In contrast to the FSJ/FÖJ, this type of service does not necessarily have to be a full-time job, though a minimum number of hours (8 hours) has to be served each week. Thus the intergenerational voluntary services may be provided in parallel with a job, apprenticeship or university course. The areas of service are similar to those of the Voluntary Social Service Year (FSJ). In 2009 the intergenerational voluntary services will become a regular voluntary service which will be realised nationwide.

3. Financial and legal status of voluntary activities

Financial status

Public Sources

It is not possible to specify the total amount of funds available for voluntary activities as their number and variety is very broad.

By the funding instrument of the Child and Youth Plan the German government ensures the framework for an effective infrastructure of youth organisations, organisations in the field of child and youth services and welfare organisations on the federal level. This well-funded infrastructure mainly fosters voluntary activities of and for young people. Besides the government funds temporary model programmes and specific activities and initiatives in the field of volunteering.

Moreover, specific voluntary activities of young people in the field of technical relief, environmental protection, agriculture, alimentation and consumer protection are funded by the Federal Ministries for Home Affairs, for Environment and for Agriculture.

On the regional level the federal states have similar child and youth plans to fund youth work. The most important public sources of funding lay in the hands of the 680 local youth welfare offices (Jugendämter).

The civic services Voluntary Social Service Year and Voluntary Ecological Service Year are funded by the host organisations/associations, the German federal states, third-parties and federal funds. In 2008 the federal government supported both services with about 19.23 million Euros. One million Euros of this sum were explicitly dedicated to the integration of disadvantaged young people into these services.

In 2008 the civic service "weltwärts" was funded with 25 million Euros by the Federal Ministry for Economic Development and Cooperation. For 2009 the budgets provides 30 million Euros. Legal status

Voluntary activities & Voluntary services

There is no specific legal status for volunteers in Germany. Volunteers have to act along the general legal conditions which partly regulate voluntary work in the aim to protect volunteers from specific risks, to compensate [financial] disadvantages resulting from volunteering, to promote volunteering through qualification or counselling, to create individual incentives for volunteers and to make volunteering possible.

Statutory Voluntary Services

The Voluntary Social Service Year and the Voluntary Ecological Service Year are regulated by law. In June 2008 the two acts on the promotion of both services were merged into a uniform legislative basis – the Act on the Promotion of Youth Voluntary Services
 (*Jugendfreiwilligendienstegesetz*) – in order to simplify the legislation. The new act enhances the educational character of the voluntary services and makes them more flexible. The law regulates the possibilities of deployment, pedagogical support and observation, includes provisions on the host organisations working in the field and fixes age-limits as well as the allowance for and social security of the volunteers.

• The framework of the **development volunteers' service "weltwärts"** is based on a guideline regulating the profile of and the support for the volunteers, the sending organisations and the partner projects in the host countries as well as the legal and financial arrangements and the administrative procedures and processes.

Others

- According to sec 14 of the Law on the Civilian Service (*Zivildienstgesetz*) young men can carry out a civic service (Voluntary Social Service Year/Voluntary Ecological Service Year) instead of a civilian service under certain conditions.
- The Law on Strengthening Voluntary Commitment (*Gesetz zur weiteren Stärkung des bürgerschaftlichen Engagements*) supports volunteering by tax reductions. Since 1st January 2007 persons who volunteer and who receive a small allowance for their commitment do not have to pay taxes up to an amount of 500 Euros per year. Furthermore, the tax-exempt amount for trainers was raised to 2100 Euros.
- Tax exemptions for non-profit organisations do exist.

5. What is the social protection of young volunteers in your country and are voluntary activities compatible with social benefits ?

Voluntary Activities

Most of the people engaging in voluntary activities have an accident insurance and a casuality insurance which is paid by the organisation/association they are volunteering for. In cases in which such insurances do not exist the insurance coverage is covered by special insurances provided by the federal states.

Statutory Voluntary Services

In particular with regard to social security, young people who sign up for a statutory voluntary service are more or less on par with other young people who are doing vocational training. The host organisations provide pocket money, accommodation, meals, working clothes or can pay a lump sum to cover these expenses. Volunteers have complete social security coverage (statutory pension, accident, health care, long-term nursing care and unemployment insurance). Their parents receive family benefits and the volunteers are given travel cost reductions on the German Railways and on public transport. The Voluntary Social Service Year and the Voluntary Ecological Service Year are both recognised by the Central Office for the Allocation of Places in Higher Education as waiting time for such a university place. For participants who carry out their service abroad the sending organisations are obliged to take care of the necessary social insurances.

Voluntary Service

Volunteers who carry out a voluntary service have to care about their insurances themselves. Often the organisations offering the places help to conclude the necessary insurances.

Voluntary Services abroad

For those people carrying out a voluntary service abroad additional insurances and measures for social security are necessary depending on the host country's conditions.

Legal situation of unemployed Young people participating in voluntary activities

According to sec 119 subsec 2 Social Code Volume II unemployed people can participate in voluntary activities up to 15 hours per week without having disadvantages in respect to their earnings-related benefits.

7. Does a strategy (plan) or specific measures for the development of voluntary activities of young people exist in your country?

Voluntary activities of young people (as well as older ones) are one of the priorities of the Federal Ministry for Family Affairs, Senior Citizens, Women and Youth. Therefore, developing the conditions for volunteering is integral part of the government's youth policy.

Promoting volunteering and participation is one of the main objectives of youth organisations in Germany. The importance of youth organisations for promoting political and civic commitment is thus always emphasised by the Federal Government, both at national and European level. Over more than five decades, the Child and Youth Plan of the Federation, which is the government's funding instrument in the field of non-formal education, has created suitable overall conditions for the nationwide youth organisations which ensure their funding and thus the funding of young people's voluntary activities on a sustained and sustainable basis.

The statutory voluntary services of a Voluntary Social Service Year (Freiwilliges Soziales Jahr) and a Voluntary Ecological Service Year (Freiwilliges Ökologisches Jahr) are of special importance. The last step for developing these services was the Act on the Promotion of Youth Voluntary Services (Jugendfreiwilligendienstegesetz) which came into force in June 2008. The new Act extended the fields of application for these services and made them more flexible in order to better meet the needs of young people and the organisations offering places (for more information see chapter 3).

Currently the government's special focus is on promoting volunteering among disadvantaged young people. Therefore, a special budget of one million Euros is allocated to different national projects and initiatives aiming at this target group. Moreover organisations active in the field of youth service and youth work are encouraged to involve this target group in their voluntary work.

8. Obstacles to volunteering of young people existing in the country and

measures to remove them

Obstacles (selection)

- Although the budget for the statutory voluntary services was raised in the last years there are still
 not enough places for all young people being interested in carrying out such a service. Every year
 the number of applicants is much higher than the number of places. In average, there are about
 twice as much interested young people as there are places in available.
- Young people who would like to carry out a voluntary service outside the statutory voluntary services (no financial support) often cannot afford the costs.
- Potential organisations/associations which would like to offer places for volunteers (statutory voluntary services) cannot afford the monthly costs for the young persons.
- Legal conditions have become more restrictive (reduction of the maximum duration for family benefits, introduction of tuition fees in some federal states) which has obstructive effects on the voluntary activities.
- Lack of financial resources for projects and initiatives (i.e. lack of basic funding).
- Socially disadvantaged young people who would like to become active, cannot afford the costs for travelling and for participation or membership fees.
- Long lead times: Young people cannot apply on short-notice for statutory voluntary services or voluntary services abroad although it could be helpful in order to bridge waiting time (i.e. between graduation and vocational training or university).
- The status of volunteers going abroad is often unclear. Sometimes they are seen as employees which causes a lot of problems.
- A lot of employers still see voluntary commitment as a disadvantage. They fear special leaves.

Measures to remove the obstacles (selection)

 With the Act on the Promotion of Youth Voluntary Services which came into force in June 2008 the federal government aimed at removing some of the obstacles to volunteering of young people. For example the time structure of the voluntary services was made more flexible. Instead of a fixed 12months-service-time the voluntary service can now vary between six and 24 months. Furthermore a combined service in Germany and abroad helps to better meet the interests of the young volunteers and the volunteering organisations.

- The new development volunteers' service "weltwärts" which started in 2008 considerably raised the number of places for young people interested in carrying out a voluntary service abroad. The budget provides funding for about 10,000 young volunteers each year.
- More and more projects and programmes focus in particular on promoting volunteering among disadvantaged young people (for examples see chapter 9).

9. How are voluntary activities of young people promoted in your country, particularly among young people with fewer opportunities?

Information channels promoting voluntary activities among young people (selection)

Young people are encouraged to become a volunteer through various information channels as well as by projects or actions programmes. To inform young people about the numerous possibilities of volunteering the Federal Ministry for Family Affairs, Senior Citizens, Women and Youth, the bodies of statutory and voluntary youth services and youth welfare as well as the federal states developed a considerable information and advise network.

10. Explain how voluntary activities of young people are recognised in your country.

Certificates

- Jugendleiter/in-Card (Juleica): Among the different certificates in Germany the Juleica is one of the
 most important ones. The card rewards the commitment and the qualification of young volunteers
 and gives various discounts for community services, cultural offers etc. It is issued after a special
 qualification training of 40 hours. The Juleica is the most common certificate for young volunteers
 in Germany. About 3000 cards are issued each month. Currently the German Federal Youth
 Council runs a project on further developing the Juleica and to make it even more attractive. >>

- Some federal states have an own form of certifying qualifications. In Baden-Württemberg the "Qualipass" documents practical experiences and competences of young people between the age of 12 and 25 acquired by voluntary commitment but also by traineeships, stays abroad etc. (www.qualipass.info). Other federal states have similar forms of documenting voluntary commitment of young people (i.e. Hamburger Nachweis, Berliner FreiwilligenPass, EhrenamtsCard in Hessen).
- Young people who carried out a Voluntary Social Service Year or a Voluntary Ecological Service Year have a right to receive a certificate informing about the form and the duration of their commitment. The certificate can also include a performance rating and the vocational qualifications the young people acquired during their service.
- Since 2006 voluntary activities of young people in international contextes are recognised by *"International Certificates"* (Nachweise International). These certificates document young people's extracurricular engagement and their personal commitment as members or leaders of a team in an international youth project. There are three kinds of certificates indicating three different stages of commitment: the International Commitment Certificate, the International Participation Certificate and the International Competence Certificate. >> More information: <u>www.open-the-world.net</u>.

Competitions and awards 2008 (selection)

- Citizens Award "für mich, für uns, für alle" (for me, for us, for all) honours citizens who showed an extraordinary commitment in the field of voluntary work. It is one of the most important awards for voluntary commitment in Germany. The category "JUNIOR" awards young people until the age of 21. Exchange opportunities for young volunteers

In general events and meetings (i.e. general assemblies) at national level offer a lot of face-to-face opportunities for young volunteers to exchange experiences. For all volunteers carrying out a Voluntary Social Service Year/Voluntary Ecological Service Year regular seminars are integral part of the programme. These seminars provide a space where young volunteers meet to share and reflect their experiences as well as to broaden their knowledge on issues related to their service.

The action day was supported by several prime presidents of the federal states and the Federal President Horst Köhler. The aim of the action was to encourage young people to get engaged in voluntary activities and to learn about
