She believes that the best preparation that young people can receive prior to embarking on their adult journey, characterised nowadays by non-linear pathways, should comprise a mix of formal and non-formal education, and that learning mobility constitutes an important element of the latter. She presently works as a youth work officer at Agenzija Żgħażagħ, the national youth agency of Malta. Youth empowerment cannot work without youth inclusion, participation, information and mobility. Her remit and challenge as a youth worker is to help young people recognise where they stand in their non-formal educational journey, and with regards to the latter to create a working environment where they will be able to identify where to progress next and what tools they will need to do so.
