# **European Platform for Learning Mobility Conferences**

The EPLM Conferences bring together researchers, practitioners, volunteers, policy makers, institutions and organisations in the youth field working on the topic of learning mobility. The next conference will be held in Autumn 2021 focusing on Learning Mobility and Sustainability, hosted by the Finnish National Agency for Erasmus+.

The European Platform for Learning Mobility in the youth field (EPLM) is an open participatory space for exchange and cooperation between practitioners, researchers and policy makers. By 'practitioners' the Platform means programme staff, trainers and consultants, youth workers and other multipliers in the youth field and in youth work.

# **Quality Mobility App**

# **Quality Ambassadors**

In Summer 2019, 60 mobility activists from the whole of Europe were selected from more than 500 applicants. They gathered in the European Youth Centre Budapest through the efforts of EU-Council of Europe youth partnership and Salto Inclusion and Diversity to become Quality Ambassadors of the EPLM Mobility Quality Tools. Currently the Ambassadors are conducting diverse initiatives in their countries and their networks. To mention a few:

- Q! webinar for SALTO-YOUTH's ToT 2018-2019 graduates
- Meetings and presentations of the Quality Manual and the Q! App in Portugal, Spain, Armenia, Turkey and Bulgaria.

### Multiplier training for Quality! Ambassadors

On 17-21 of May 2020, JINT (National Agency for the Flemish Community in Belgium) will host 15 experienced and 30 new Q! Ambassadors for a training course in Ostend. The call for applications will be announced in January 2020.

# T-kit on Learning Mobility is being developed

EUROPEAN PLATFORM ON LEARNING MOBILITY in the youth field

Following the recent developments of the European Youth Programmes and the launch of European Solidarity Corps in 2018, a new training kit (T-kit) is being prepared, with the support of the youth partnership in cooperation with European Solidarity Corps Resource Centre. The T-kit is going to be focused on value-based learning in learning mobilities, which will also include aspects related to solidarity. The team is planning to have it finalised by the end of 2020.



# Youth Sector Strategy 2030

The Council of Europe youth sector strategy 2030 has four thematic priorities:

- Revitalising pluralistic democracy;
- Access to rights;
- Living together in peaceful and inclusive societies;
- Youth work.

A high-level launch of the Youth sector strategy 2030 has been proposed in January 2020 within the framework of the chairmanship of Georgia of the Committee of Ministers.

# Youth Participation Strategy

SALTO Participation and Information is developing a Youth Participation Strategy to enhance youth participation through Erasmus+ and the European Solidarity Corps programmes. Some members of EPLM take part in the expert group that is supporting the development of this strategy. In the beginning of May 2020, a conference is planned to launch the Strategy.

# The European Youth Card services will be available in more countries

Recently the EYCA GA has welcomed new member organisations from North Macedonia, Italy, Bosnia & Herzegovina, and Belarus.

As of 2020, the European Youth Card services will be available in all these territories.

Erasmus+ KA3 project "Youth for Human Rights" exploring and advancing the role and potential of youth

Youth for Human Rights

The last activity was a closing conference in Tallinn, on 29-30 of October.

On 10th of December, Human Rights Day, **policy recommendations** coming from the project have been published. They contain suggestions for follow up on policy and practice level.

# Exploring different models of democratic participation: fostering youth participation through the European Youth Card

The seminar aimed to:

- Offer the space for debate on and recognition of the variety of forms in which young people make their voices heard, including through digital means;
- Explore the ways in which European Youth Card can be a tool to reach out to disengaged young people and encourage them to actively participate at all levels.

The seminar brought together policy makers in the youth field, youth workers, youth activists and young people, both organised and non-organised, as well as from various structures of representation (e.g. young people involved in the "Rejuvenating politics" initiative of the Congress of Local and Regional Authorities of the Council of Europe). # Eurodesk study 2019

The 2nd edition of the Eurodesk survey shows trends and preferences of how young people find, engage with, and perceive youth information about mobility opportunities. The report focuses on understanding young people's preferences and identifying what stakeholders in the field of learning mobility can do to better reach out to youth. **Read the report here.** 



# DesYlgn: Innovative Youth Information Service Design and Outreach Focus Group Interview Report

As part of the Erasmus+ DesYIgn project, Åbo Akademi, in cooperation with ERYICA, have written a report on focus group interviews that were conducted with young people. Eight focus group interviews were carried out in four different countries. which were: UK (Wales), Spain (Valencia and Madrid), Malta, and Luxembourg. A total of 37 young people aged between 15 and 29 and with an average age of 19 participated in the in-depth discussion, where they elaborated on their everyday informationseeking practices, their level of awareness of the services, their challenges in accessing the services, and how they would prefer using such information services. The report includes recommendations for youth information service providers and decision-makers, and will be published in January 2020.

# **Desk Research on Indicators of Impact**



A recent desk research was conducted by a group of researchers who have established that:

- assessing (social) community impact is very difficult because there are other influential factors;
- the indicators to understand the (social) impact in communities are scarse and the ones available are not very accurate (difficult to understand if one is talking about sending or hosting community);
- positive effects are acknowledged in both sending and hosting communities (learning effects, fostering cooperation, involvement in community issues, etc.);
- it is necessary to develop indicators to evaluate social impact at the community level.



# **EU-Council of Europe youth partnership publications**

- A Youth Knowledge Book on Social Inclusion and Digitalisation;

**The Concept of Solidarity** the European Solidarity Corps Resource Centre

4Thought project was conducted in 2019 in order to find common ground on the concept of solidarity in the European youth field. The study represents input from all the four angles of practice, policy, research and young people, from sectors that the Solidarity Corps covers. The report of the study is soon to be published. 


# Engage. Inform. Empower.

Eurodesk, the European Youth Card Association (EYCA) and the European Youth Information and Counselling Agency (ERYICA) came together for the Erasmus+ project "3 Network Project: Enhancing Youth Service Promotion and Outreach", with a new publication of best practices from all around Europe.

The ePublication addresses a variety of ways for reaching out to young people through outreach youth work, reaching out to young people through digital tools, and building youth workers' capacities.

# Follow-Up of the Access-Study

In the follow-up of the German research project "Access-Study", transfer e.V. coordinated a series of events to disseminate the findings and discuss perspective strategies in local contexts, but also internationally. Three symposiums were held in France, Poland, and Albania to discuss the European dimension of the study. In January the discussion will be continued in Finland. On March 9-10 a final conference is going to bring different perspectives together and draw conclusions on the ways of accessing international youth work and the obstacles young people face when it comes to participation.

# **Evidence-based approach in Erasmus+. Methodological aspects**

The seminar will be followed by a publication composed of diverse articles on learning mobility and methodology.



The Foundation for the Development of the Education System – Polish National Agency of the Erasmus+ Programme organised the third edition of the seminar on evidence-based policy in Erasmus+ which took place on October 9-10 2019 in Poland.

The goal of the seminar was to provide a scientific forum for discussion on educational research methodology with a special attention to international mobility projects within the Erasmus+ Programme.

# Symposium "The future of young people's political participation: questions, challenges and opportunities"

From 18 to 20 September 2019 the partnership between the European Commission and the Council of Europe in the field of youth organised a symposium. Over 120 participants explored current tensions, questions, challenges and opportunities regarding the political participation of young people in today's changing world and created a space for learning and inspiration among actors involved in this topic.

# Enhancing Youth Services: Promotion and Outreach

In the framework of cooperation between ERYICA, Eurodesk, and EYCA organised a common training event for the members of the three networks based on their needs of youth service structures in optimising the promotion and attractiveness of their services among young people and establishing efficient digital communication and outreach strategies.

a publication with good practices on youth outreach and digital communication strategies is being developed.

# Give a Vote campaign

Implemented with the help of EYCA members in EU member states, the campaign aimed to increase young voter turnout in the upcoming EU elections. The campaign features:

- 26 young activists
- European events such as youth exchanges;
- 50.000 special edition EU elections of the European Youth Card distributed across Europe;
- Post-election meeting between young activists and the European Parliament representatives;
- Strong on-line presence.

**Results**:

- 10 influencers engaged & 4.4 million fanbase reach on Instagram;
- 4.43 million young people reached through YouTube ads



# Conference "Youth mobility in a digitalized world"

May 12 - 14, 2020, Germany

The three-day conference, initiated by JUGEND für Europa (German NA for E+YIA and ESC) and IJAB (International Youth Service of the Federal Republic of Germany), aims at giving an overview on the status quo in the youth mobility field, at sparking discussion and at developing recommendations for further steps. Target groups:

- Multipliers who are active in European and/or international youth mobility (volunteers as well as paid staff) and who are interested in the topic or who have expertise in this area.
- Participants from all program and partner countries of the Erasmus+ Youth in Action program can take part.





Mentoring under construction



European Solidarity Corps Resource Centre is working on quality for support roles, looking at mentoring and the tools that are developed for mentors. In 2020, the Resource Centre will organise a seminar to gather tools and resources for mentors. # **Mobility Taster for Inclusion Organisations**

SALTO Inclusion & Diversity Resource Centre continues their work with newcomers to Erasmus+ Youth and European Solidarity Corps who are directly working with young people from disadvantaged backgrounds. There are 3 courses planned for 2020: in Austria in March on volunteering, in Ukraine in June on youth exchanges and volunteering (in Russian), and in North Macedonia in October/November on youth exchanges and volunteering (in English).

Mobility Taster course gives concrete examples of what is possible, brings organizations in contact with other inclusion youth organisations, shows what funding is available specifically for youth inclusion projects and walks the participants step-by-step through the process in case they would like to give it a try.
