Ádám Nagy habil. PhD has various degrees (engineering, economics, political science, education, law, health care), with a habilitation in pedagogy. At this time he is a research professor at the Pallasz Athéné University and an associate professor at the Hans Selye University. He was the founder and editor-in-chief of the periodicals *Civil Review* and *New Youth Review*, the president of the Leisure-time Pedagogy Section of the Hungarian Pedagogical Society and the vice president of the Youth Researcher Section of the Hungarian Sociological Association. His research areas include leisure-time pedagogy, youth affairs and the civil society.

Anna Fazekas was born in 1989 in Budapest. She graduated in 2014 with a Master's in Sociology. She was lead researcher at the Excenter Research Centre and currently works as a freelance researcher. Her key research areas include youth sociology, the sociology of leisure, media sociology and social psychology.

Betty Tsakareistou is Assistant Professor and Head of the Advertising and Public Relations Lab at the Department of Communication, Media and Culture at Panteion University. She was a visiting Lecturer at Copenhagen Business School, and has been part of the CCEBI research network (2013-16) and the MBA Programme of the University of Cyprus (2007-11). Her research focuses on the mobile, sharing and collaborative economy and consumption; start-up entrepreneurship and social innovation; and cities as platforms for co-creation and innovation. In 2016, Betty was appointed Branding Officer and European Co-Liaison of the International Communication Division of the Association for Education in Journalism and Mass Communication. The year previously, she received a grant from the US Department of State and participated as a visiting scholar at the Study of the US Institute on Journalism and Media at Ohio University. The same year, she also launched (as editor) a book series on digital culture with Pedion Publishing and co-initiated the Connecting Cities Project, a digital transmedia storytelling initiative for innovative urban public diplomacy, connecting five cities across four continents. She has served on the Board of Directors of the Institute of Communication in Athens since 2002, and is a member of the Advisory Board of Impact Hub Athens. She is also a member for Greece for the COST/European Literacy Network programme (from 2014) and has served as a media literacy expert for the European Commission (from 2010).

Lida Tsene holds a PhD from the Department of Communication, Media and Culture at Panteion University (2010) in the field of social media and social responsibility. Since 2008, she has collaborated with the Advertising and Public Relations Lab of Panteion University as researcher and teaching associate. She worked as adjunct professor at the Department of Informatics and Mass Media of the Technical Educational Institution of Western Greece (2010-2014) and since 2012 has taught the MA Communication and New Journalism at Cyprus Open University as well as (since 2013) the MA Cultural Organizations Management at the Hellenic Open University.
