Aim and objectives of the seminar

The seminar aims to make a contribution to the access to rights of young refugees and migrants by offering a space for different sectors to understand the situation of this group and to build cross-sectoral bridges, on the basis of the knowledge developed by different fields, and particularly the youth field.

The seminar has the following objectives:

- 1. Develop a better understand of young refugees and migrants' situation and how different sectors work with this group, also building on the knowledge developed in the youth field
- 2. Create a space for mutual understanding and synergies among different actors acting in one way or another for young refugees and migrants
- 3. Disseminate and learn from good practices of cross-sectoral co-operation and of working with young refugees and migrants
- 4. Identify gaps in intervention for further planning and development in different fields.
