### Gymnasia programme

- Curriculum comprises 3 basic parts:
  - Four year and compulsory subject
  - Unspecified periods of certain number which must be completed by students. Aim is to broaden the student knowledge in their chosen subjects and preparing for matura exam (14% of the entire programme)
  - Elective compulsory activities of fixed scope (6,6% of the entire programme)



#### Matura

- External exam
- 5 subjects:
  - 3 compulsory: mother tongue, math, foreign language
  - 2 electives (history, geography, psychology, biology, chemistry etc.)
- Condition of enrollment in academic studies
